**Software License Agreement for Salling Clicker**  
**Single Use License**

**PLEASE READ THIS SOFTWARE LICENSE AGREEMENT CAREFULLY BEFORE PRESSING THE "AGREE" BUTTON. BY PRESSING "AGREE," YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT, PRESS "DISAGREE" AND (IF APPLICABLE) RETURN THE SOFTWARE TO THE PLACE WHERE YOU OBTAINED IT FOR A REFUND.**

**This Salling Software End User License Agreement accompanies a Salling Software software product and related explanatory materials ("Software"). The term "Software" shall also include any upgrades, modified versions or updates of the Software licensed to you by Salling Software. This copy of the Software is licensed to you as the end user.**

Salling Software grants to you a nonexclusive license to use the Software, provided that you agree to the following:

**1. Use of the Software.**

The Software you are installing is a "trial version". As such, you may evaluate the Software given certain functional restrictions as described in the documentation accompanying the Software. If you decide to continue using the Software, you agree to register it by purchasing a serial number at our web site ([www.salling.com](http://www.salling.com)). This "trial version" of the Software can be turned into a registered copy by providing such a serial number (licensed to you by Salling Software) while you are inside the software. Once registered, the Software may either be used by one person who uses the software exclusively on up to three computers, or installed onto a single computer that is used non-simultaneously by multiple people. If the software is installed onto multiple computers and more people than the original licensee will use the software, additional users must obtain serial numbers for themselves. The portions of the Software designed for handheld computers and smartphones may only be used with the portions of the Software designed for computers.

**2. Copyright.** The Software is owned by Salling Software, and its structure, organization and code are the valuable trade secrets of Salling Software. The Software is also protected by International Copyright Law and International Treaty provisions. You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code or structure of the Software. You may use trademarks only to identify output produced by the Software, in accordance with accepted trademark practice, including identification of trademark owner's name. Such use of any trademark does not give you any rights of ownership in that trademark. Except as stated above, this Agreement does not grant you any intellectual property rights in the Software.

3. **Transfer.** You may not rent, lease, or sublicense the Software. You may, however, transfer all your rights to use the Software to another person or entity, provided that you transfer this Agreement with the Software, retain no copies—including backup copies and copies installed on a computer—and the receiving party accepts the terms and conditions of this agreement.

4. **No warranty.** The Software is being delivered to you AS IS and Salling Software makes no warranty other than that the Software shall conform to the specifications in the documentation during a warranty period of three months from delivery. Salling Software will only remedy deviations from the specification providing that the deviation substantially affects your use of the Software and it is not caused by third-party software, scripts, firmware, and/or hardware. Salling Software may under such circumstances choose to replace your copy of the Software with a new one.

APART FROM ABOVE SALLING SOFTWARE DOES NOT AND CANNOT WARRANT THE PERFORMANCE OR RESULTS YOU MAY OBTAIN BY USING THE SOFTWARE OR DOCUMENTATION. Place of jurisdiction is Stockholm, Sweden. Salling Software can also, however, at its free discretion, open proceedings at the registered address of the Licensee. This Agreement shall automatically terminate upon failure by you to comply with its terms. This Agreement may only be modified in writing signed by an authorized officer of Salling Software.
