

## LICENSE AGREEMENT

1. LicenseThe WPA Film Library ("WPA") grants you the non-exclusive license to use the images recorded on the accompanying CD ROM (the "WPA Images") employing QuickTime(tm) software (the "QuickTime(tm) Software") only in accordance with the provisions of this license agreement. All rights to and in the WPA Images, including, but not limited to, copyrights and trade secret rights, belong to WPA and WPA holds title to each copy of the WPA Images. The WPA Images shall only be used on a single computer at one time, except as specifically authorized by this license, or in writing in conjunction with a separate licensing agreement from WPA. This license authorizes you to copy or transfer the WPA Images for domestic home use or for internal professional use by developers and within corporations and institutions for "in-house" purposes, including for purposes such as the development of prototypes, demonstrations, trade shows, training films, sales films and educational tutorials. The WPA Images may be used for performances in a private home, in an educational, religious or charitable institution, or by a commercial enterprise (other than an enterprise engaged in broadcasting, cable transmission or other publication activities) for performances that carry out the business activities of the enterprise, provided that such performances are non-public and no admission fee is charged. This License Agreement shall automatically terminate in the event of any transfer or distribution of the WPA Images in violation of the terms of this License Agreement.

2. TermThis License Agreement is effective until terminated. You may terminate this License Agreement by returning the WPA Images to WPA. WPA may terminate this License Agreement if you breach any of the terms and conditions. Upon termination of this License Agreement for any reason, you shall return the WPA Images to WPA. All provisions of this License Agreement relating to disclaimers of warranties, limitation of liability, remedies, or damages, and WPA's proprietary rights shall survive termination.

3. Limited WarrantyWPA warrants that the media on which the WPA Images are furnished will be free from defects in materials and workmanship under normal use for a period of thirty (30) days from the date of delivery ("Warranty Period"). Your exclusive remedy under this limited warranty is the replacement of any defective physical media on which the WPA Images are furnished. To receive a replacement for defective media under this limited warranty, return the defective media to WPA during the Warranty Period with proof of payment.
