

**wyUpdate End-User Software License Agreement**  
Version 1.2, October 2008

A source code version of certain wyUpdate functionality that you may use, modify, and distribute is available to you free-of-charge from <http://wyday.com> under the wyDay Public License and other open source software licenses.

The accompanying executable code version of wyUpdate and related documentation (the "Product") is made available to you under the terms of this wyUpdate End-User Software License Agreement (the "AGREEMENT"). BY CLICKING THE "ACCEPT" BUTTON, OR BY INSTALLING OR USING WYUPDATE, YOU ARE CONSENTING TO BE BOUND BY THE AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT CLICK THE "ACCEPT" BUTTON, AND DO NOT INSTALL OR USE ANY PART OF WYUPDATE.

**1. LICENSE GRANT.** wyDay grants you a non-exclusive license to use the executable code version of the Product. This Agreement will also govern any software upgrades provided by wyDay that replace and/or supplement the original Product, unless such upgrades are accompanied by a separate license, in which case the terms of that license will govern. If you have purchased a Single User License, one copy of the SOFTWARE may be used, for internal use only, by one single user ("the USER"). If you have purchased a Multiple User License (you specified several copies of the SOFTWARE when you purchased it), the SOFTWARE may be used, for internal purposes only, by the number of USERS authorized at the time of purchase.

The USER MAY: (a) use the Professional edition of the Product (namely wyUpdate Professional Designer) in a company, corporate or organization that makes for-sale products, open source products, or entirely free products; (b) use the Express edition of the Product (namely wyUpdate Express Designer) for open source products or free products; (c) make a copy of the Product for archival purpose only; (d) install the Product on another computer only if the user changes to a different workstation. In such a case the user must uninstall the software from the previous workstation; (e) install the Product on a second personal computer, such as a laptop or a home computer, only if the USER is the main person to use this computer; (f) copy and distribute the wyUpdate Client portion of the Product.

**2. RESTRICTIONS.** The USER MAY NOT: (a) use the Express edition of the Product (namely wyUpdate Express Designer) to create updates or manage versions for "for-sale" products (b) copy and distribute the Product or any portion of it outside of the single wyUpdate Client executable; (c) sublicense, lease, rent, or transfer the Product to another; (d) cause or permit reverse engineering, disassembly, decompilation or alteration of the Product; (e) remove any product identification, copyright notices, or other notices or proprietary restrictions from the Product; (f) copy the documentation accompanying the Product.

**3. TERMINATION.** If you breach this Agreement your right to use the Product will terminate immediately and without notice, but all provisions of this Agreement except the License Grant (Paragraph 1) will survive termination and continue in effect. Upon termination, you must destroy all copies of the Product.

**4. PROPRIETARY RIGHTS.** Portions of the Product are available in source code form under the terms of open source licenses (collectively, "Open Source Licenses") at <http://wyday.com>. Nothing in this Agreement will be construed to limit any rights granted under the Open Source Licenses. Subject to the foregoing, wyDay, for itself and on behalf of its licensors, hereby reserves all intellectual property rights in the Product, except for the rights expressly granted in this Agreement. You may not remove or alter any trademark, logo, copyright or other proprietary notice in or on the Product. This license does not grant you any right to use the trademarks, service marks or logos of wyDay or its licensors.

**5. PRIVACY POLICY.** You agree to the wyDay Privacy Policy, made available online at <http://wyday.com/privacy.php>, as that policy may be changed from time to time. When wyDay changes the policy in a material way a notice will be posted on the website at <http://wyday.com> and when any change is made in the privacy policy, the updated policy will be posted at the above link. It is your responsibility to ensure that you understand the terms of the privacy policy, so you should periodically check the current version of the policy for changes.

**6. DISCLAIMER OF WARRANTY.** The product is provided "as is" with all faults. To the extent permitted by law, wyDay and wyDay's distributors, and licensors hereby disclaim all warranties, whether express or implied, including without limitation warranties that the product is free of defects, merchantable, fit for a particular purpose and non-infringing. You bear the entire risk as to selecting the product for your purposes and as to the quality and performance of the product. This limitation will apply notwithstanding the failure of essential purpose of any remedy. Some jurisdictions do not allow the exclusion or limitation of implied warranties, so this disclaimer may not apply to you.

**7. LIMITATION OF LIABILITY.** Except as required by law, wyDay and its distributors, directors, licensors, contributors and agents (collectively, the "wyDay Group") will not be liable for any indirect, special, incidental, consequential or exemplary damages arising out of or in any way relating to this agreement or the use of or inability to use the product, including without limitation damages for loss of goodwill, work stoppage, lost profits, loss of data, and computer failure or malfunction, even if advised of the possibility of such damages and regardless of the theory (contract, tort or otherwise) upon which such claim is based. The wyDay Group's collective liability under this agreement will not exceed the greater of \$500 (five hundred dollars) and the fees paid by you under the license (if any). Some jurisdictions do not allow the exclusion or limitation of incidental, consequential or special damages, so this exclusion and limitation may not apply to you.

**8. EXPORT CONTROLS.** This license is subject to all applicable export restrictions. You must comply with all export and import laws and restrictions and regulations of any United States or foreign agency or authority relating to the Product and its use.

**9. U.S. GOVERNMENT END-USERS.** This Product is a "commercial item," as that term is defined in 48 C.F.R. 2.101, consisting of "commercial computer software" and "commercial computer software documentation," as such terms are used in 48 C.F.R. 12.212 (Sept. 1995) and 48 C.F.R. 227.7202 (June 1995). Consistent with 48 C.F.R. 12.212, 48 C.F.R. 27.405(b)(2) (June 1998) and 48 C.F.R. 227.7202, all U.S. Government End Users acquire the Product with only those rights as set forth therein.

**10. MISCELLANEOUS.** (a) This Agreement constitutes the entire agreement between wyDay and you concerning the subject matter hereof, and it may only be modified by a written amendment signed by an authorized executive of wyDay. (b) Except to the extent applicable law, if any, provides otherwise, this Agreement will be governed by the laws of the state of New Hampshire, U.S.A., excluding its conflict of law provisions. (c) This Agreement will not be governed by the United Nations Convention on Contracts for the International Sale of Goods. (d) If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. (e) A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. (f) Except as required by law, the controlling language of this Agreement is English. (g) You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms; the wyDay may assign its rights under this Agreement without condition. (h) This Agreement will be binding upon and inure to the benefit of the parties, their successors and permitted assigns.
