## No Child Left Behind

The McGregor School District participates in all required testing by the Minnesota Department of Education. The Minnesota Comprehensive Assessments (MCA II's) for reading and math are currently given in grades 3-8. The ninth graders take the written test, the tenth graders take the reading test and the eleventh graders must take the math assessment. These tests must be passed before a student graduates from high school.

Last year science tests were piloted in the elementary and high school at McGregor. All of the academic subjects tested in Minnesota are used to determine whether schools and districts are making adequate yearly progress toward the federal mandate of all students being proficient by 2014 in accordance with the "No Child Left Behind" legislation.




### Title I Programs Offer Basic Skills Help

#### **Goal Statement One**

Staff and students have been informed about the bullying policy and have been working with the Olweus program to promote character education and positive student interaction with one another. In addition, elementary morning meetings to discuss student expectations have been implemented.

#### Goal Two

### Integration of technology to improve teaching and increase learning.

The McGregor School District has always been a leader in the region with the use of technology to enhance student learning. K-12 staff have been sent to the TIES Conference to enhance their knowledge of educational technology. The staff then integrates the use of technology in their classrooms to provide students the opportunity to learn using the most up-to-date teaching methods. EdLine is also available to high school parents and students as a way to communicate with the teacher about assignments and reporting.

#### Goal Three

#### Integration of state standards into curriculum.

The curriculum of McGregor classes has been aligned with state standards. Graduation requirements also align with state graduation requirements.

# **BST Phasing Into MCA II's**

The Minnesota State Department of Education is phasing out the Basic Standards Tests traditionally given in grade 8. The Students in the classes of 2008 and 2009 all passed those tests. The MCA II's contain new graduation requirements for students graduating after the class of 2009. These new graduation requirements are imbedded in the MCA II's.

There is a Grade 9 writing component, a Grade 10 reading component and a grade 11 Math component. In the 2007-08 school year there were 144 students enrolled in grades 9-12 at McGregor. 98% of those students passed the basic graduation requirements



portion of the MCA II's. 3% of our students graduated at an individual level based upon an IEP or a section 504 plan. The chart below contains other mandated information for your review.

### **Curriculum Review Process** — Improvement Plan

A district wide curriculum review cycle has been established that spans a period of five years. Each year the plan is updated and revised. This allows each curriclum area to be researched by representatives of the K-12 staff, school board and community. While researching the area, the group writes an improvement plan. The final report is then presented to the school board for action. The following school year, plans are implemented and actions taken based on the improvement plan. During the next three years of the cycle, the new plans continue to be utilized along with yearly follow-ups.



The curriclum and improvement plan during the 2007-2008 school year focused on social, science, and world language. Plans were developed at the elementary level, as well as specific outcomes for high school courses.

Additional improvement plans are part of the general district improvement effort. A committee structure is used to focus on student achievement and use data to set goals. The following committees were established for the 2007-2008 school year:

- ▼ Staff Development
- ▼ Career/Technical
- ▼ Health and Safety
- ▼ District Leadership Team
- ▼ Systems Accountability Team (Testing)
- ▼ Technology

### **Graduation Requirements**

In addition to the required Minnesota tests, students at McGregor are required to successfully complete 50 high school credits. This year the requirement for graduation from McGregor High School has changed because we went back to the seven period day and semesters. Over the next two school years these new requirements will be phased in for seniors. This year, the seniors will need to have 51 credits in order to graduate. The following subject areas are required for statewide accountability and for graduation:
