This Evaluation License applies to any source code, executable code, integrated circuit design, user guide or other work that Apple Computer, Inc. ("Apple") makes publicly available with a notice stating that it is subject to the terms of this Apple FireWire Reference Platform Evaluation License ("Evaluation License").

Permitted Uses, Conditions & Restrictions

Subject to the terms and conditions of this Evaluation License, Apple hereby grants You, effective on the date You accept this Evaluation License and download the FireWire Reference Platform, a royalty-free, non-exclusive, non-transferable license to use the FireWire Reference Platform only: (i) for Your Internal Evaluation or Personal Use; and (ii) to make Error Corrections.

You may make copies of the FireWire Reference Platform only if reasonably necessary for your Personal Use or Internal Evaluation or to make Error Corrections. You must retain and reproduce in all copies the Apple copyright and other proprietary notices and disclaimers as they appear in the FireWire Reference Platform, and keep intact all notices in the FireWire Reference Platform that refer to this Evaluation License or to the Use License. You must also duplicate, to the extent it does not already exist, the notice in Exhibit B in any Error Corrections created by You, and cause the modified files to carry prominent notices stating that You changed the files and the date of any change.

- B. Exhibit A

Definitions

Whenever capitalized in the Evaluation License, the following terms will be defined as follows:

“Contributor” means any person or entity that creates or contributes to the creation of the FireWire Reference Platform or an Error Correction.

“Error Correction” means any bug fix or other Modification that corrects or works around, or is intended to correct or work around, a reproducible defect in the FireWire Reference Platform that causes it to fail to operate in a material manner or produce incorrect or substantially incorrect results.

“Evaluation License” means this FireWire Reference Platform Evaluation License, including all Exhibits attached to it.

“Internal Evaluation” means use of the FireWire Reference Platform or an Error Correction by a corporation, business or organization (or by an individual in his or her capacity as an officer, employee, member, independent contractor or agent of a corporation, business or organization) internally only and only for the purpose of evaluating the FireWire Reference Platform.

“Modification” means any addition to, deletion from, and/or change to, the substance and/or structure of the FireWire Reference Platform, any previous Modifications, the combination of FireWire Reference Platform and any previous Modifications, and/or any respective portions thereof, including, without limitation, any Error Correction. When code is released as a series of files, a Modification is: (a) any addition to or deletion from the contents of a file containing the FireWire Reference Platform and/or any previous Modification; and/or (b) any new file or other representation of computer program statements that contains any part of the FireWire Reference Platform and/or a previous Modification.

“FireWire Reference Platform” means the source code, executable code, integrated circuit design, and documentation made available by Apple for download under this Evaluation License which contain a header file stating that they are subject to this Evaluation License.

“Personal Use” means use of the FireWire Reference Platform or a Modification by an individual solely for his or her personal, private and non-commercial purposes. An individual's use of the FireWire Reference Platform or Modification in his or her capacity as an officer, employee, member, independent contractor or agent of a corporation, business or organization (commercial or non-commercial) does not qualify as Personal Use.

“You” or ***“Your”*** means an individual or legal entity exercising rights under this Evaluation License. For legal entities, ***“You”*** or ***“Your”*** includes any entity which controls, is controlled by, or is under common control with, You, where ***“control”*** means (a) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (b) ownership of fifty percent (50%) or more of the outstanding shares or beneficial ownership of such entity.
