1.0 مرحبًا بك في SUSE Linux Enterprise Server

1.1 الحد الأدنى من متطلبات النظام

- معالج Pentium* السرعة 500 ميغا هرتز أو أعلى (يفضل معالج Pentium 4 بسرعة 2.4 غيغا هرتز أو أعلى أو أي معالج من النوع AMD64/Intel* EM64T)
 - ذاكرة RAM فعلية مساحتها 512 ميغابايت (تُفضل مساحة 1 غيغابايت)
 - توفر مساحة 2 غيغابايت على القرص (تفضل مساحة أكبر)
 - دقة عرض 800 × 600 (1024 × 768 وتُفضل دقة أعلى)

أدخل قرص الفيديو الرقمي الخاص بالمنتج SUSE Linux Enterprise Server في محرك الأقراص، ثم أعد تشغيل جهاز الكمبيوتر لبدء تشغيل برنامج



2. حدد التثبيت من شاشة التشغيل ثم اضغط المفتاح Enter. يتم من خلال هذا الإجراء تحميل برنامج تثبيت SUSE Linux Enterprise Server، ويبدأ تشغيل التثبيت في الوضع العادي.



- 3. حدد اللغة المطلوب استخدامها أثناء التثبيت وللنظام المثبّت.
- اقرأ اتفاقية الترخيص، ثم انقر فوق نعم، أوافق على اتفاقية الترخيص. قم بالمتابعة بالنقر فوق التالي.



5. حدد ما إذا كنت تريد تنفيذ تثبيت جديد أم تحديث من إصدار سابق من SUSE Linux Enterprise Server. قم بالمتابعة بالنقر فوق التالي.



6. حدد الساعة والمنطقة الزمنية المطلوب استخدامهما في النظام لديك. قم بالمتابعة بالنقر فوق *التالمي*.




7. حدد ما إذا كنت تريد التثبيت كنظام تشغيل أساسي على جهاز فعلى أو كضيف ظاهري في جهاز XEN من خلال تحديد جهاز ظاهري أو كمضيف ظاهرية يمكنه تشغيل أجهزة ظاهرية أخرى باستخدام الخيار مضيف ظاهرية XEN. قم بالمتابعة بالنقر فوق التالي.



8. استخدم شاشة إعدادات التثبيت لعرض عدد من خيارات التثبيت والتقسيم المقترحة، ثم قم بتغيير الخيارات المطلوبة إذا لزم الأمر.

تحتوي علامة التبويب نظرة عامة على خيارات أساسية تحتاج أحيانًا إلى التدخل اليدوي (في معظم حالات التثبيت الشائعة). تحتوي علامة التبويب خبير على خيارات تكوين متقدمة.

انقر فوق قبول لقبول أية اتفاقيات ترخيص.



10. قم ببدء تشغیل التثبیت باستخدام تثبیت.

بعد الانتهاء من إعداد النظام الأساسي وتثبيت كافة حزم البرامج المحددة، سيتم تشغيل تثبيت SUSE Linux Enterprise Server في نظام Linux الجديد. بعد إعادة التشغيل، ستظهر الشاشة التالية:



11. أدخل كلمة سر لحساب مسؤول النظام (الذي يسمى المستخدم المسؤول).

يجب عدم نسيان كلمة سر المسؤول. بعد إدخال كلمة السر هنا، لا يمكن استرداد كلمة السر. ويمكن إعادة تعيينها فقط من خلال المساعدة الإدارية. قم بالمتابعة بالنقر فوق *التالي.*



12. أدخل اسمًا لهذا الكمبيوتر ومجال DNS الذي ينتمي إليه. قم بالمتابعة بالنقر فوق التالمي.



13. من الشاشة "تكوين الشبكة"، قم باستعراض اتصالات الشبكة للنظام لديك أو تغييرها.

إذا كانت لديك أجهزة شبكة (مثل بطاقات الشبكة أو البطاقات اللاسلكية أو وصلة DSL أو محول ISDN أو جهاز مودم)، فالأفضل أن يتم تكوين هذه الأجهزة الآن، وذلك لأن الاتصال بالإنترنت يتيح للمنتج SUSE Linux Enterprise Server إمكانية استرداد أية تحديثات متاحة ويقوم بتضمينها في عملية التثبيت. قم بالمتابعة بالنقر فوق *التالي*.
