安裝快速入門

使用以下程序安裝新版 SUSE® Linux Enterprise Server 11 SP2。本文件提供有關如何在 x86、x86_64 和 ia64 架構上完成 SUSE Linux Enterprise Server 預設安裝的快速綜覽。

最低系統要求

- Pentium* III 500 MHz 或更高版本處理器 (建議使用 Pentium 4 2.4 GHz 或更高版本,或是任一 AMD64/Intel* EM64T 處理器)
- 512 MB 實體 RAM (建議 1 GB)
- 2 GB 可用磁碟空間 (建議更大)
- 800 x 600 顯示器解析度 (建議 1024 x 768 或更高)

安裝 SUSE Linux Enterprise Server

如果您的機器上目前未安裝 Linux 系統或是您希望取代現有的 Linux 系統,請依照這些指示執行。

1. 將 SUSE Linux Enterprise Server DVD 插入光碟機,然後重新啟動電腦以啟動安裝程式。



2. 在開機畫面中選取「安裝」,然後按 Enter。這會載入 SUSE Linux Enterprise Server 安裝程式,並以一般模式啟動安裝。



- 3. 選取安裝期間以及所安裝系統要使用的語言。
- 4. 閱讀授權合約,然後按一下「*是,我同意授權合約*」。 按「*下一步*」繼續。



5. 決定是要執行「*全新安裝*」還是從舊版 SUSE Linux Enterprise Server 進行更新。按「*下一步*」繼續。



5. 選取系統中使用的時鐘和時區。按「*下一步*」繼續。



7. 決定是要做為「實體機器」上的主要作業系統、還是透過選取「*虛擬機器*」做為 XEN 機器內的虛擬訪客,或使用選項「*XEN 虛擬化主機*」做為可在其他虛擬機器上執行的虛擬化主機進行安裝。按「*下一步*」繼續。



8. 使用「安裝設定」畫面檢視多個建議的安裝與磁碟分割選項,然後根據需要變更所需選項。

「綜覽」索引標籤包含有時需要手動介入的基本選項 (在最常進行的安裝情況下)。「*進階*」索引標籤包含 進階組態選項。

9. 按一下「接受」,接受所有授權合約。



10. 按一下「安裝」開始安裝。

完成基本系統設定並安裝了所有選定軟體套件後, SUSE Linux Enterprise Server 安裝會開機進入新的 Linux 系統。重新開機後您將看到以下畫面:



11. 請輸入系統管理員帳戶 (稱為 root 的使用者) 的密碼。

切勿忘記 root 的密碼! 在此處輸入密碼後, 您將無法再從系統取回密碼。只有在管理協助下才能重設該密碼。按「下一步」繼續。



12. 為此電腦輸入一個名稱,並輸入此電腦所屬的 DNS 網域。按「*下一步*」繼續。



13. 在「網路組態」畫面中,檢視或變更系統的網路連線。

如果您擁有網路設備 (例如,網路卡或無線介面卡、DSL 連線、ISDN 介面卡或數據機),最好現在設定這些設備,因為網際網路連線可讓 SUSE Linux Enterprise Server 取回並安裝任何可用的更新。按「下一步」繼續。



- 14. 按一下「*是,測試與網際網路的連線*」,測試網際網路連線。此選項也可檢查 SUSE Linux Enterprise Server最新的版本說明。按「*下一步*|繼續。
- 15. 在「正在執行網際網路連接測試」畫面中檢視測試結果。按「*下一步*」繼續。



16. 按一下「立即設定>下一步」,在「Novell 客戶中心 組態」畫面中啟用系統的線上更新。

按一下「*稍後設定>下一步*」略過這個步驟,並繼續進行安裝。產品安裝好後,即可設定此選項。按「*下一步*」繼續。



17. SUSE Linux Enterprise Server 預設會為系統建立一份 憑證。若要停用此功能,請按一下「*跳過組態 > 下一步*」。按「*下一步*」繼續。



18. 在「使用者驗證方式」畫面中選取「*本地* (/etc/passwd)」,除非您的系統管理員另有指示。按 「*下一步*」繼續。



19. 在「*使用者全名*」欄位中鍵入您的名字與姓氏,在「*使用者名稱*」欄位中鍵入您的登入名稱,在「密碼」欄位中鍵入您的密碼 (系統管理員所推薦的密碼)。

基於安全因素,您的密碼至少必須有 8 個字元長度, 且應包含混合的大寫、小寫字母及數字。密碼最大長 度為 72 個字元,並且區分大小寫。按「*下一步*」繼 續。



20. 系統組態完成後,檢視版本說明。按「下一步」繼續。



21. 使用「硬體組態」畫面檢視或設定您的圖形卡及其他 硬體設備。按「*下一步*」繼續。



- 22. 在「安裝已完成」畫面中,按一下「完成」,關閉 SUSE Linux Enterprise Server 安裝並繼續進入登入畫面。
- 23. 輸入您的使用者名稱,並在「密碼」欄位中輸入您的密碼,然後按 Enter。
