WinSched - Windows Scheduler

WinSched is a program scheduler for Windows. It initially allows you to schedule up to five different events to execute at a later date and time. If you need more than five events start WinSched with a numeric parameter.

For example:

Start WinSched by typing "WinSched 2". This allows you to schedule up to ten different events. This will create two copies of WinSched. Each copy will schedule up to five different events. By typing "WinSched 3" this allows you to schedule up to 15 different events. This will create three copies. WinSched is limited only by your systems resources. All copies of WinSched must be running in order for it to process its list of events, but it can be minimized.

To enable or disable an event, select the box next to the event. All other operations are performed through the File menu:

Print Schedules

This selection will print a list of all the events currently scheduled. The schedule is printed in the following format:

Title Title displayed in the window.

Program name Name of the program, batch file or PIF file to run.

Enabled flag 1 = Enabled

0 = Disabled

Run time What time the event is scheduled to run.

Skip next flag 1 = Skip next

0 = Don't skip next

Run once flag 1 = Run once

0 = Run always

Last Which day it last ran

Alarm 1 = Alarm only

0 = Run program

Days S = Sunday


M = Monday T = Tuesday W = Wednesday H = Thursday F = Friday A = Saturday

Print Setup

This selection allows you to change the default printer for Windows.

Change Program

This selection allows you to enter/change a scheduled program. Select one of the program slots - 1 through 5. A dialog box will then be displayed to enter all the information:



Title - Enter the title to be displayed on the main window and on the printout.

Sound/Program - If the Alarm option is selected, enter the names of the WAV file to play when the alarm triggers. Enter only the file name and .WAV extension, the file must be in the WinScheduler directory or the WINDOWS directory or in the search path. No path information can be used or specified. If the Alarm option is not selected, enter the name of the program, batch file, or PIF to run. The file name must be fully qualified if it is not in the DOS PATH.

Days - Select the days to run the program. An 'X' next to the day enables it.

Time - Use the UP or DOWN arrow on either side of the time display to change to the desired time and select AM or PM.

Run once - Select this box if the program should be run only once. After the scheduler runs the program it automatically disables it.

Skip next - Select this box to skip the next scheduled run of the program. The scheduler will automatically enable it after it skips the next run. The Skip next option can be used if you need to run a scheduled program immediately or if you don't want it to run again at the normally scheduled time.

Alarm only - Sounds an alarm and displays a message box at the specified time. This option does not run a program. When the program box changes to a Sound box, enter the name of the WAV file to play when the alarm triggers. If no WAV file is specified, or it can't be found the WIN.INI file is searched for the default system sound. If no sound driver, such as Sound Blaster or speaker.drv is installed, no sound will be played.

Browse - Allows you to select the program to run or the alarm sound to play.

<u>Exit</u>

Exits the program.

Delete Program

This selection will delete the selected program. Select which entry to delete. All information will be cleared.
