Maintenance

A. Volume Purchase Option and Contract Option

Sites may purchase Maintenance on an individual basis. Once Maintenance is selected, it must be purchased for the entire Term, for the entire Product Family for Lotus Notes or Lotus oc:Mail, and for individual applications for Desktop Products. Lotus offers Maintenance based on the following Software categories:

- (i) Lotus Notes (full product, companion products and gateways);
- (ii) Lotus cc:Mail (full product, companion products and gateways);
- (iii) Desktop Products (all products other than communication products)

Once Maintenance is selected, it must be purchased for the entire Agreement Term by Product Family, and must be purchased for all subsequent Software licenses acquired within that Product Family. If a Passport Customer with either Lotus Notes or Lotus cc:Mail servers or clients purchases Maintenance, it must also purchase Maintenance with any subsequent licenses of companion products. Also, if Maintenance is purchased for a Lotus Notes or Lotus cc:Mail companion products, it must also be purchased for all subsequentlicenses of client/server Software. For Desktop Products, a Site may choose to purchase Maintenance for one or any combination of products in that category. Once a Site purchases Maintenance for a Desktop Product, the Site must purchase Maintenance for all subsequent licenses of that Desktop Product made during the Agreement Term.

B. Enterprise Option

For Enterprise Option customers, Maintenance is required for the full Agreement Term.

C. Site Maintenance Contact

Each Site wishing to purchase Maintenance must complete an Enrollment Form and assign a Site Maintenance Contact. The Site Maintenance Contact is the person responsible for assisting Lotus with Maintenance renewals and for overall Maintenance compliance for the Site.

D. Maintenance Purchases

A Site may elect to purchase Maintenance for Lotus software not under Maintenance (whether or not such software was purchased under the Program) at any time during the Agreement Term. Once Maintenance is purchased for a Product Familty, the Passport Customer must continue to purchase Maintenance for all subsequent licenses of Software within that Product Family.

Thirty (30) days prior to the Maintenance Anniversary Date, Lotus will send to each Site a notification report summarizing the Site's Maintenance purchases during the first year of the Agreement Term and calculating the pro rata fees for the second year of Maintenance. Each Site must identify the Passport Reseller on the report for invoicing purposes, have an authorized representative sign the completed report, and return the completed report to Lotus. Within 30 days of the Site's receipt of the Maintenance report, the Site must submit a purchase order to the Passport Reseller for the second year of Maintenance.

5. Maintenance Media Shipping Contact

Each Passport Customer Site purchasing Maintenance under the Lotus Passport Program will receive one set of media for each commercially-available product upgrade. Lotus will ship product upgrade media to the address indicated below. The media will be shipped in the product language also selected below. Lotus may replace these items with a CD-ROM subscription service, if and when available. Maintenance must be purchased before any upgrade will be shipped.
