## ***1. Office of the Prime Minister***

*Besides the ministers responsible for each ministry, there is a number of deputy prime ministers taking charge of various responsibilities undertaken by the Office of the Prime Minister which in itself ranks as a ministry. The Prime Minister's Office is largely concerned with formulating the national policy. One of its primary subdivisions, the Budget Bureau, prepares the nation's annual budget. The National Economic and Social Development Board lays out longer term development planning. The Office of the Council of State provides expert assistance in drafting laws and gives ruling on questions concerning administrative law. It remains quite distinct from the Justice Ministry, which administers laws after they are promulgated. Several other organizations, such as Office of the Civil Service Commission and the Public Relations Department also fall under the responsibility of the Prime Minister's Office.*

This shall be achieved by the mobilization and retention of the armed forces so that they are capable of defeating enemies in combats and wars; upholding the monarchy institution; suppressing rebels and social unrests; facilitating the Kingdom's development; and safeguarding the Kingdom's other interests as stipulated and operating certain industries as well as energy sources upon which its legal obligation to defend the Kingdom's depends.*

*The decision to use armed forces in carrying out the aforementioned missions shall be under the authority of Ministry of Defence-except that of suppressing rebels and social unrests which shall also be approve by the Cabinet's resolution.*

*Role and responsibilities of the Finance Ministry have been developed over time along with a series of the nation's development schemes. As current defined in the Public Administration Act, the Ministry is empowered to oversee various matters concerning public finance, taxation, treasury, Government property, operations of Government monopolies, revenue-generating enterprises which can be legally operated only by the Government and not under the purview of other Government bodies, as well as other organizations to which the Government has contractual obligations. It is also vested with the power to provide loan guarantees for the Government, agencies, financial institutions, and state enterprises*
