1. The Product

The CD-ROM contains **2,940** photographs in digitized form. The rights to use the photographs are owned by Comstock, Inc. or its represented photographers who have granted to Comstock the right to include their photographs in the CD-ROM. (Comstock, Inc. and these photographers are collectively referred to as Comstock and the photographs are referred to as Comstock Desktop Photography® in this agreement.)

The CD-ROM also contains version 1.0 of Comstock's Photo Browser, a software application. The user may not alter the CD-ROM in any way, by reverse engineering, decompiling, disassembling or modifying the software.

2 Copyright Licence Validation

Upon receipt by Comstock of the Product Registration/Copyright Validation Request, which is included with the CD-ROM, completed by the company or individual in whose name the licence is to be registered (the Registered User) Comstock will validate the licence described below for the use of the Comstock Desktop Photography®.

The Registered User of the Comstock Desktop Photography® does not acquire any right, title or interest in or to any works derived from any of these photographs except for the usage permitted below.

The Registered User is permitted to use this CD-ROM at one location at a time. The CD-ROM can be mounted on only one server.

3 Permitted Usage

Comstock agrees to validate the licence granted herein to the Registered user to use the Comstock Desktop Photography® for the following purposes only:

- a) Non-commercial In-house Usage, defined as those uses in which the primary recipient is an employee or member of the Registered User and the primary function of the printed product is to educate or inform and not to sell a product or service.

Examples of Non-Commercial In-house Usage include but are not limited to: newsletters distributed free of charge, memos, internal training manuals or teaching aids; invitations, signs and reports that are not for resale and not for promoting business. In addition the photographs may also be used in the promotion of normal corporate activities such as picnics, parties, charitable fundraisers and other primarily social or charitable events which will be considered non-commercial in nature, even if an admittance fee is charged, as long as the primary function is to entertain employees and/or members, and not to promote business.

- b) Comp Usage, defined as the creation of a rough layout or comprehensive rendering for the purpose of displaying to a client, or potential client, the final visual style and substance of a creative work, which is intended to be used for a commercial

- b) No model release or other releases exist for any photograph unless the existence of such release is specified in writing by Comstock. Registered User hereby indemnifies and holds Comstock harmless against any and all claims, expenses and liability of any kind arising out of or in connection with the use of the Comstock Desktop Photography® where the existence of such release has not been specified in writing by Comstock and for the defamatory use of a photograph in any manner or context. In any event the limit of liability of Comstock shall not exceed the sum paid by the Registered User for the CD-ROM.
- c) This licence is not assignable or transferable on the part of the Registered User.
- d) Comstock reserves the right to withdraw any photograph in the Comstock Desktop Photography® from this licence. Comstock shall also have the right to terminate this licence at any time upon repayment to the Registered user of the cost to the Registered User of the CD-ROM.

However, in the event of breach of this licence by the Registered user, Comstock may terminate this licence without further notice and without payment.
