In General

The following items pertain to both "Registered Owners" and "Loaner Disk Users" as specified below:

- A) The ACP-ProBill software shall be used only for the registered owner's normal and legal business activities in which the software is applicable. Activities may be extended to include architects, project owners, contractors, subcontractors, educactional entites, and lending facilities with which the registered owner maintains business relationships through the free distruibution of "loaner disks".
- B) Print outs in the "AIA" format of the ACP-ProBill generated data shall be on either plain paper for internal use only, or on the official AIA copyrighted forms obtained from sources authorized by the American Institute of Architects.
- C) No user (registered or not), nor anyone else, may alter or modify the ACP-ProBill Software. You cannot give anyone else permission to modify the software.
- D) All rights not expressly granted in this license agreement are reserved entirely to Harley J. Brook, dba ACP-ProBill Systems.
- E) This agreement shall be governed solely by the laws of the State of Florida.

Registered Owners

A registered copy of the following versions of ACP-ProBill software may be used to create progressive billing dataBase files, and to print out the data on AIA G701\G702\G703 forms or the alternate Invoice form:

- A) The "FULL FEATURED" version may be installed on an unlimited number of workstations by the registered owner, his associates, or his employees. The original registered copy shall be used to make the "loaner" copies for distribution to the registered owner's associates and employees, if those workstations are not on the registered owner's network. Only the "loaner disks" may be freely distributed and then solely at the risk of the registered owner.
- B) The "*EVALUATION*" version of the ACP-ProBill software is restricted to THREE projects. It may not be copied, nor distributed in any manner whatsoever. It may be installed on only one workstation and in a directory named ?:\acp-eval. This version maybe upgraded to the full version at any time without loss of project data and then the directory may be renamed. The tutorial project "SAMPL" may deleted and recreated as many times as needed.
- C) The "*ACADEMIC*" version is strictly a teaching tool limited to 3 projects at any one time. It is FREE for educational entities and copies may be freely distributed to facilty, students, and others by using the "loaner disk" feature. There is no restriction as to the number of workstations that it may be installed on.

- D) The "*ARCHITECT'S*" version is strictly a tool limited to 3 projects at any one time. It is FREE to architects and architectual firms, but may be freely distributed to facilty, students, and others by using the "loaner disk" feature. There is no restriction as to the number of workstations that it may be installed on.
- E) The "*TUTORIAL*" version is full featured, however it is limited to creating only the tutorial project named "SAMPL". This tutorial project may deleted and recreated as many times as needed. All other versions also included this tutorial capability. It may be freely copied and distributed to any other interested parties by using the "loaner disk" feature. There is no restriction as to the number of workstations that it may be installed on.

Loaner Disk Users

This is not free software, but rather a copy of one of the above versions on 3.5" floppies provided to you by the registered owner of the software. At any time, you may upgrade your "loaner" software and it will be converted to the registered Full Featured version without any loss of any dataBase files you may have created. The use of the "loaner" software is subject to the following conditions:

- A) You are hereby licensed to use the "loaner" disks of ACP-ProBill software in the conduct of your business or educational relationship with the registered owner that provided them to you.
- B) You are licensed to make exact copies of the loaner disks and provide them to other interested parties for evaluation purposes only.
- C) Distribution of the software and documentation via the internet, email, or other electronic means is strictly prohibited.
- D) You are specifically prohibited from charging or requesting donations, for any such copies, however made; and from distributing the software and/or documentation with other products (commercial or otherwise) without prior written permission.
