- (2) Current motor vehicle (MV) letter dated 3-4-93 which I recieved today requesting proof of insured motorist.
- (3A) MV's previous letter to me dated 6-18-93 from office of Skip Lee, Director of MV, stating my registration WILL NOT be revoked because PROOF OF COVERAGE WAS RECEIVED.
- (3B) Original MV letter to me dated 5-28-92 requesting proof of insured motorist. I responded to this immediately (see 3A).
- (4) PROOF OF CURRENT INSURED MOTORIST policy declaation and issued insurance card. Policy# LV0032938-60.
- (5) Proof of insured motorist policy declaration and insurance card for accident period date 3-24-92. Policy# MPM2121752.
- (6) Proof of insured motorist policy declaration and insurace card for period immediately following the accident, making sure I had coverage pending MTF's (Market Transition Facility which governs the insurance company) review for original policy (MPM2121752) reinstatement. Reinstatement did occur. Temporary insurance policy# 340-2292 / MPM7024272 for this period.
- (7A) and (7B) MTF and HCM Claim Management Association LETTERS CONFIRMING REINSTATEMENT OF POLICY# MPM2121752 and application of premiums paid on policie# 340-2292 / MPM7024272 to the original policy MPM2121752 and of NO LAPSE IN ORIGINAL POLICY COVERAGE over any

period of time including the accident period 3-24-92.

Dear Mr. Skip Lee, Director of Motor Vehicles,

This is the second time your office of motor vehicles has sent me a letter requesting proof of insurance coverage and today is the second time I am sending you (via registered mail) both proof of previous full coverage with no lapses, and in addition, proof of current coverage through a better carrier.

During the period of time of the accident (3-24-92) there was a matter of a missing payment by check which the insurance company could not locate, but I was able to supply proof of payment to the MTF (Market Transition Facility which governs the insurance company) such that quick REINSTATEMENT of policy# MPM2121752 was enforced with NO LAPSE OF COVERAGE over any period of time including the accident period. A letter from the MTF and from HCM Claims is supplied as proof of these proceedings. I have also enclosed proof of CURRENT COVERAGE through the National Consumer Insurance Company and previous coverages through the Market Transition Facility of NJ. I also took specific steps to make sure I was indeed covered during the period in which the MTF was reviewing my case. Further, I did send to your previous letter my registered mail and provided to you proof of my coverages. You returned a letter to me notifying me my proof was adequate and no suspensions would occur.

I am obligated to request that you please review my records once again which I have enclosed, and update your motor vehicle records pertaining to me, showing, finally, for all times sake, that I am indeed, in actuality, in good standing with your office of motor vehicles. Kindly forward me a letter as you did last time, stating motor vehicle's satisfaction with the proof I have supplied. I await your letter.

Thank you for your assistance in this urgent matter.
