

Installer note:

Once you have selected the location for your installation and click on the "Accept" button, the installer will present you with options to install the application for your type of Macintosh. This may be a Power Macintosh or an "older" 680x0 Macintosh. The installer will allow you to install either version or a version (called FAT) which will operate on any Macintosh. Please note that the installer will default to the version which is specific to your hardware.

Notice:

Color It! 3.2 is copyrighted software. It may not be distributed or copied, except for making a single backup of the data. The license agreement allows you to use Color It! on more than one computer, provided that not more than one copy is operating at the same time.

To use Color It! for more than one machine at a time (i.e. a computer lab or network situation), you must purchase additional licenses for the software.

(b) Title in and to the Software and documentation remains exclusively in MFI, subject to express, limited and non-exclusive license granted to you pursuant to paragraph 1.

(c) The Software contains proprietary information which MFI considers trade secrets and confidential proprietary to MFI. You shall not use, disclose, nor permit any person to obtain such proprietary information, except to the extent such information is necessary for the normal use of the Software.

(d) You agree that this license shall be governed by and construed in accordance with the laws of the State of Iowa. Any action commenced relating to the terms and obligations of this license of the Software provided under this license must be brought within one (1) year after such action accrues and shall be

commenced in the State of Iowa.

(e) If any provision of this license is determined to be invalid or unenforceable that provision shall be deemed severed from the remainder of this license and the remaining provision of this license shall remain in full force and effect.
