The 32 bit version of ZR FileWorks is out. It is called Omega Drive, current version is 1.2. It is nearly identical to ZR FileWorks 8.2 with some differences. First is that ZR Satellite (32 bit verison) is not included with Omega Drive file but requires a separate download. ZR Satellite is still free for Omega users as it is for ZRFW users. That it requires a separate download is due to the fact that ZR Satellite 32 has features that some users may not want, such as integration into the Explorer shell to create ZIP files in any directory, and becomes the default program for ZIP files. Now both Omega Drive and ZR FileWorks can support other unzip programs as the default program besides ZR Satellite. Omega Drive like ZR FileWorks has the ability to unzip files internally as well as use ZRSAT to unzip them. Omega Drive also has a screen capture program that ZR FileWorks does not. ZR FileWorks on the other hand, does play AVI, MPEG, MOV (requires drivers to be present, most new computers come with these drivers) and such while still being able to show Jpegs, Gifs, and such which Omega Drive cannot. I am not even going to begin to list the features of these programs here as it would take far to long to list them all. I however planning on a further comparison of these to versions on the Scandere Software web site of
