

The We-Blocker icon is the small "We" symbol in your computer's system tray (generally located at the bottom right-hand corner of your screen next to the clock).

Either right or left clicking on this icon will display all the available options for your We-Blocker account, including the ability to access the Master Controls and logging on or off a User Account.



We-Blocker allows you to set up a password-protected personalized account for each member of your household. Each account is given a certain set of restrictions based on our seven categories of blocked material. You are NOT required to add users to use We-Blocker.

On setup, the software automatically installs a Master User account, which can be edited but not deleted. The Master User controls the software and can create and customize additional accounts.

By default We-Blocker will automatically open in Guest Mode each time you start your computer. This feature can be edited or disabled all together through the Master Controls.

To log-in under your individual account, right or left click the "We" icon in your system tray, then select "Change Current User" from the menu. A dialog box will appear prompting you to enter your user name and password.



To uninstall We-Blocker

- **1.** Go to your Start Menu.
- 2. Under "Programs," choose "We-Web," then from the resulting menu select "WeUninstall".
- 3. You will be prompted to enter your PARENT account password.

Provided that the password is correct, We-Blocker will completely uninstall itself.

Some websites and banner ads may be blocked that the user did not expect to be blocked and may not agree with the blocking of. The user accepts this blocking as a condition of The Product use. If the level of filtering is not acceptable to the Licensee, it is their option to uninstall the software. The Master Controls is the command center of your We-Blocker Filtering Software. Here you can add, edit and delete user accounts, customize filtering, monitor Internet access for each user, and add and remove blocked web sites.

Only the Master Account has access to Master Controls which can be opened by right or left clicking on the "We" icon in your system tray.

It is very important to keep track of your Master Password, as without it, you will not be able to access the Master Controls. Tech support charges \$10 for lost password help.
