What is DocLimit?

What is DocLimit? DocLimit is a utility that limits the number of “recent” document files that appear on your Windows 95 Start menu. See Figure 1, below. Without a utility such as DocLimit, the recent documents list will continue to grow as you launch files. Without DocLimit, your only option is to remove all documents when the list becomes too large.

DocLimit allows you to specify exactly how many documents remain on the documents list. You can even have DocLimit keep the list empty if you so desire. DocLimit resides on the Windows 95 system notification area or “tray.” See Figure 2, below.

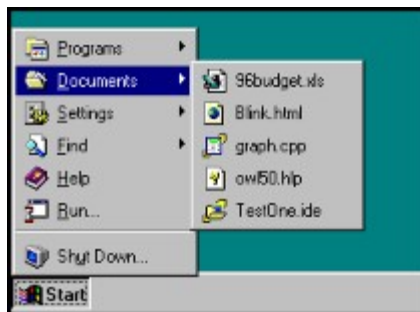

Installing DocLimit

1. Create a new folder called DocLimit.
2. Copy all DocLimit files to the new DocLimit folder.
3. Create a shortcut to the file DOCLIMIT.EXE.
4. Place the shortcut in: 'C:\WINDOWS\StartMenu\Programs\StartUp'

NOTE: See your Windows 95 documentation for information on how to create shortcuts.

Using DocLimit

To change DocLimit's settings just double click the DocLimit icon located on the system tray. Within the configuration dialog (see Figure 1) you can adjust how many documents are retained.

Also, DocLimit functions may be accessed by right-clicking on the DocLimit icon. Right-clicking the DocLimit icon will cause a pop-up menu to appear. See Figure 2.

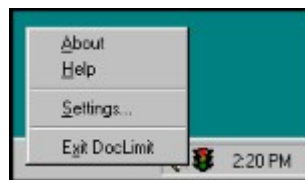

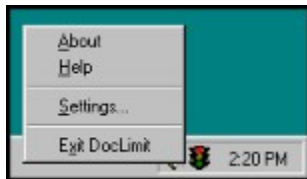
Shutting Down DocLimit

Normally you would leave DocLimit running all the time. However, if you wish to shut down DocLimit, right-click the DocLimit icon on the system tray (see Figure 1) and choose “Exit DocLimit.”

Why is 15 the maximum number of documents?

This is because Windows 95 only shows a maximum of 15 documents on the recent documents list. It would be silly for DocLimit to allow more documents than Windows 95 itself allows.
