## **INSTALLATION:**

1. In your Windows directory make a sub-directory ELCALC and change to that directory:

```
MD ELCALC<Enter>
CD ELCALC<Enter>
```

2. Copy the files to the ELCALC sub-directory:

```
COPY A:*.* C:<Enter>
```

3. If disk space is limited, erase the ZIP file from the sub-directory:

```
ERA *.ZIP<Enter>
```

4. Start Windows:

```
CD ..<Enter> WIN<Enter>
```

- 5. Start the File Manager and reduce the size of the File Manager window so that part of the Program Manager window is visible.
- 6. Go to the ELCALC sub-directory and use the mouse to drag the OHM\_LAW.EXE icon to the Program Manager window and drop it.
- 7. Close the File Manager and drag the OHM\_LAW icon to the appropriate Program Manager group and drop it.
- 8. Double-click on the OHM\_LAW icon to start the application.
