By registering, you ensure that software authors like myself can continue to bring you quality software at reasonable prices.

By allowing you to try my software BEFORE you buy it, you are able to make the determination if it will meet your needs before you pay for it....There is nothing worse than spending \$\$\$ on a new software program because it sounded great on the box and then when you get it home, the program is awful. Of course the store won't take it back because you have already opened the package.

ShareWare has solved this problem by letting people try-before-you-buy. It is entirely on the honor system and it is up to you to register it if you plan on using the program.

CHANGES

- Was written in "C" and didn't include as many options.

SOFTWARE LICENSE

EZ-Soft is not and has never been public domain software, nor is it free software.
