

## **LIQUIDLIBRARY USER GUIDE**

Each liquidlibrary monthly issue includes two hybrid CDs (Macintosh and Windows compatible) containing photographs, illustrations and a variety of media files. To search images, an Extensis® Portfolio™ Browser catalog is included. To preview the images, simply copy the catalog (liquidlibrary.fdb) and the Portfolio Browser folder to your hard drive. A user guide for Extensis Portfolio Browser is located in the Portfolio Browser folder.

### **FILE FORMATS**

#### **PHOTOGRAPHY**

Photographs are JPEG compressed and provided in RGB color. The images are saved in three sizes in the following folders:

##### High

Includes: 50 MB (approx.), 11 x 17 inches, 300 dpi

##### Medium

Includes: 14 MB (approx.), 6 x 9 inches, 300 dpi

##### Low

Includes: 2 MB (approx.), 9 x 14 inches, 72 dpi

#### **ILLUSTRATION**

JPEG compressed illustrations are provided in RGB color at approximately 9 x 12 inches, 300 dpi.

EPS illustrations are saved as Adobe Illustrator EPS version 5.0 files and provided in CMYK color.

Each color illustration found in the Color Illustration folder has a black & white version found in the B&W Illustration folder.

#### **MEDIA MIX**

The file types offered in the Media Mix folder will vary from month to month and may include any of the following:

.PPT - PowerPoint files are saved in a Microsoft PowerPoint 98-2001 Presentation format.

.FLA - Flash files are saved in a Macromedia Flash 5 format.

.MOV - QuickTime movies are saved as QuickTime 4 format.

.JPG - JPEG files are provided in RGB color at approximately 10 x 7.5 inches, 72 dpi.

.WAV - WAV files are sampled at 48khz 16 bit.
