Distribution Requirements

Individuals who wish to distribute the PATIENCE ABROAD package to friends or associates may do so in accordance with the restrictions outlined in LICENSE.DOC.

Computer Clubs and User Groups wishing to add the PATIENCE ABROAD package to their disk library may do so in accordance with the Distribution Restrictions listed below.

If you would like your Computer Club or User Group to be placed on our mailing list for future upgrades to any of our products, please contact us for complete details. Our address and phone number is listed in DESCRIBE.DOC.

Limited Distribution License:

As the exclusive copyright holder for PATIENCE ABROAD, CoCoWare authorizes distribution only in accordance with the following restrictions.

ASP Approved Vendors in good standing are hereby given permission to distribute the PATIENCE ABROAD package. Non-ASP member vendors must request permission prior to distributing this package.

- PATIENCE ABROAD, Version 1.00 - Vendor.DOC -

The PATIENCE ABROAD package is defined as containing all the material listed in the PACKING.LST text file. If any files listed in the PACKING.LST text file, or the PACKING.LST file itself, are missing, then the package is not complete and distribution is forbidden. Please contact us to obtain a complete package suitable for distribution.

The PATIENCE ABROAD package - including all related program files and documentation files - CANNOT be modified in any way and must be distributed as a complete package, without exception. The PACKING.LST text file contains a list of all files that are part of the PATIENCE ABROAD package.

Small additions to the package, such as the introductory or installation batch files used by many shareware disk vendors, are acceptable.

No price or other compensation may be charged for the PATIENCE ABROAD package. A distribution fee may be charged for the cost of the diskette, shipping and handling, as long as the total (per disk) does not exceed US\$8.00 in the U.S. and Canada, or US\$12.00 internationally.

The PATIENCE ABROAD package CANNOT be sold as part of some other inclusive package. Nor can it be included in any commercial software packaging offer, without a written agreement from CoCoWare.

The PRINTED User's Guide may not be reproduced in whole or in part, using any means, without the written permission of CoCoWare. In other words, the disk-based documentation may not be distributed in PRINTED (hardcopy) form.

The PATIENCE ABROAD package cannot be "rented" or "leased" to others.

You may not list any of our products in advertisements, catalogs, or other literature which describes our products as "FREE SOFTWARE". Shareware is "Try-Before-You-Buy" software, it is not free.

Vendor Update Program:

Most non-ASP vendors have standard procedures for acquiring new files. They get them from other vendors, BBSs, etc. Most authors cannot afford to mail disks to hundreds (perhaps thousands) of vendors. However, some vendors prefer to obtain programs directly from the authors. If you would like to obtain programs directly from us, automatically, then please help us to cover the cost.

If you are NOT an ASP Approved Vendor (in good standing), but you would still like to receive automatic updates directly from us, then please take advantage of our Vendor Update Program. Under this program you can receive updates for an entire year for only \$10 per program (this helps to offset our costs).

To receive updates, simply send us a letter with your name, company name, mailing address, the name of the person we should contact (such as your disk librarian), the program (or programs) for which you would like to receive updates, and a check or money order for \$10 for each program (Countries outside of North America please add an additional \$10 per program). Payment in U.S. funds drawn on a U.S. bank only please.
