Introduction

Remind-It is a program which plants itself in your system tray and reminds you to do things which you configure into the program at a set interval. Take me for instance, I like to take breaks from staring at the monitor for long periods of time, but I always forget because I'm too wrapped up in whatever I was doing! But with Remind-It installed, I configure it to pop-up every hour or so and tell me to take a break while it plays a song and shows me an image.

When the break is over, it hides itself again until the next break arrives. You can also use this to just remind yourself that you have to go somewhere while you are using the computer etc. In short, this can be a lifesaver, and an eye-saver of a program.
