(a) Every person subject to the tax, except persons whose gross income (1) consists solely of salary, wages, or similar compensation for personal services rendered, or (2) arises solely from the business of growing and selling products of the soil, shall . . . keep such permanent books of account or records . . . .

[Code of Federal Regulations, Title 26 (1939), page 1738]

The Social Security Franchise would make me a "TAXPAYER", therefore sections 9.21-1, 9.22(b)-1, and 9.54-1 would not apply to me. My "WAGES" with respect to "EMPLOYMENT" would be the formula by which the revenue laws measure the taxes. The "Self-Employed" compensation for personal services rendered by a person who receives it "From Sources WITHIN the United States" is the formula by which the Revenue Laws measure the taxes. Therefore, I would be UNDER A DUTY to keep such books and records, and I would be required to file a "Tax Return" by regulations promulgated by the Secretary.

The provisions of Article 1, Section 2, Clause 3 and article 1, Section 9, Clause 4, and , for that matter, any of the Articles of the Bill of Rights, which specifically protect the same individual, are of no value for any individual that applies for and uses a number that encompasses the Social Security Scam!

If I wish to conduct "Private Enterprise", I must do it on my own, without assistance from the Government. I have never asked for assistance, nor will I. Henry Campbell Black defines these rights as the Common Law Entrepreneurs:

**Proprietary**, n. A proprietor or owner; one who has the exclusive title to a thing; one who possesses or holds the title to a thing in his own right. The grantees of Pennsylvania and Maryland and their heirs were called the proprietaries of those provinces. Webster.

**Proprietary rights.** Those rights which an owner of property has by virtue of his ownership. When proprietary rights are opposed by acquired rights, such as easements, franchises, etc., they are more often called "Natural Rights".Sweet.

[Black's Law Dictionary, Third Edition (1933), page 1449]

I have just a few more comments concerning the term "Nonresident Alien Individual". Under our Constitution, the Territories are land areas which are in pupilage to become States of the Union. How can the Federal Government, under Title 26 U.S.C., treat the citizens of the Commonwealth of Puerto Rico as subjects? The citizens of the Commonwealth of Puerto Rico are pupils, waiting and studying to become a State of the Union of States! The United States Supreme Court confirmed this in the following:

Citizens of Puerto Rico are not aliens. [Gonzales vs Williams, 192 U.S. 1]

How does the Federal Government take this Kingly attitude towards Puerto Rico, and deny the citizens of the commonwealth their rights under the Constitution? It doesn't! The "alien resident of Puerto Rico" is the Sovereign Citizen, who does not work for, who does not do business with, and who did not volunteer into the Social Security Scheme. He has not derogated his Sovereignty by associating in any way with the Federal Government.

You must remember, to be Constitutional, any portion of Title 26 that deals with "income" is written under the authorities of Article 1, Section 8, Clause 17 and article 4, Section 3, Clause 2. The only logical thing for Congress to do, then, is to consider the pupils of Puerto Rico as "Nonresident Alien Individuals". Remember, the Fifty Sovereign States are not included (per definition) in the land areas over which Congress has "exclusive legislative jurisdiction".

Therefore, as you can plainly see, you had no authority to compel me to join Social Security. You had no authority to tell Citizens in the States of the Union that Social Security account numbers were mandatory. The only issue left to be resolved is fraud, treason and sedition. The Social Security Scheme was a trap to create slaves of the remaining free people within the States of the Union. I will not be one of them. You see, I took the time to read the Analysis of the Social Security System, Hearings before a Subcommittee of the Committee on Ways and Means, House of Representatives, Eighty-Third Congress, First Session on The Legal Status of OASI Benefits, November 27, 1953." Do not tell me that this document does not contain irrefutable proof and material evidence of fraud. For example, see pages 935 and 936.

Therefore, you will now notify all pertinent and appropriate Federal and State entities that I am not covered by , and do not participate in the Social Security System., and that the number xxx-xx-xxxx formerly associated with my name is no longer valid, thereby restoring partially what has been taken from me, due to your constructive fraud.

Now, **for the record**, let me state the following facts:

I have never been required to have, hold and/or obtain a Social Security account number. Yet, by government's usage of undue influence concerning a birth registration and employment applications, I was misled to believe mistakenly that a Citizen in one of the several united States of America was required to have such an identification number and/or account. I have never been naturalized by Congress, nor are any of my rights conferred by Congress, because I am a natural born Citizen (see 2:1:5 in the U.S. Constitution) and a white male domiciled in the California Republic.

It is quite obvious to me now that the U.S. Constitution does not grant to Congress the power to legislate for, or against, any of the independent sovereign States within the Union of America. Congress can legislate by usage, under the scope and purview, of the so-called 14th Amendment, under which courts have determined that Congress was enabled to govern *artificial* persons or entities, which I am not. Moreover, Congress has exclusive legislative jurisdiction over its

territories, possessions, and enclaves only by virtue of the authorities granted to it by Article 1, Section 8, Clause 17 and Article 4, Section 3, Clause 2 in the U.S. Constitution.

I have recently had a physical examination and my learned doctor has told me that I am white, I am an adult, I am a human being, and I have always been a human being ever since my birth in \_\_\_\_\_ on \_\_\_\_\_. At no time in my life have I ever consented with foreknowledge to being an artificial entity, such as is a creation of Congress or of the "United States", or a Federal citizen, nor was I born in the "United States", nor have I ever been a resident of the "United States".

**The birth and Social Security registrations that were forced upon me, without my consent of majority and without knowingly intelligent acts on my part, are therefore null and void, *ab initio*.**

I refuse to be considered as a stranger in the California Republic, such as a "United States citizen" or a "resident alien". I do not vote; I revoked my voter registration because it required me to sign an affidavit affirming, under penalty of perjury, that I was a "United States citizen", but it failed to define the meaning of "United States" in this affidavit. I have never received nor made application for any type of Social Security benefits. I have never knowingly, intentionally and voluntarily consented to these purported Social Security benefits given by Congress. I cannot and will not accept any such quasi contractual agreements, particularly when all associated terms and conditions were not fully disclosed to me.

In concluding this reply to your letter of \_\_\_\_\_, 1992, let me make myself perfectly clear, this is:

### **ACTUAL AND CONSTRUCTIVE NOTICE**

Attached, as exhibit A, you will find a Power of Attorney Revocation, dated \_\_\_\_\_, recorded in \_\_\_\_\_ County, \_\_\_\_\_. I am a de jure California Citizen, not a de facto Federal Citizen under the so-called 14th Amendment. and a ward of Congress, who has a taxable citizenship through Social Security or any other type of governmental franchise. No governmental agency has power of attorney over me or my property. (see Exhibit A, attached)

This revocation is based upon the principle that a writing is "Void Ab Initio" in the case of fraud in the inception, and it need not be formally rescinded as a prerequisite to a right of avoidance.

[*Bonacci vs Massachusetts Bonding and Ins. Co.*, (1943) 58 CA2d. 657, 664, 137 P2d. 487]

Therefore, I am again demanding that you remove my name from the number xxx-xx-xxxx, and from your system of records, that you notify my workplace and any all concerned governmental agencies, that I am not subject to, nor required to have a social security number, and to provide me with a letter addressed to: "To Whom It May Concern", stating those facts. Also, I demand

that your agency return all of my property that was taken by your use of the various elements of fraud; which is available under Section 204, of the Social Security Act, (49 STAT 620), which allows for recovery of unqualified individuals. Furthermore, if there is an administrative procedure necessary or required to accomplish these demands then I demand that you inform me of the details of that procedure immediately, at the address listed below my signature.

This letter and attachment, all previous letters, affidavits, declarations and affirmations, sent to you, the Social Security department, and or the Department of Health and Human Services or any other governmental agency, (are incorporated by this reference as if set forth fully herein), are conclusive and direct evidence of fraud and have not and cannot be refuted by any lawful means. Therefore, as such shall be conclusive evidence, of the admissions and confessions of fraud and entrapment in any court of law or any other proceedings.

The means of "knowledge", especially where it consists of public records is deemed in law to be "knowledge of the facts". As the means of "knowledge" if it appears that the individual had notice or information of circumstances which would put him on inquiry, which, if followed, would lead to "knowledge", or that the facts were presumptively within his knowledge, he will have deemed to have had actual knowledge of the facts and may be subsequently liable for any damage or injury. You, therefore, have been given "knowledge of the facts" as it pertains to this conspiracy to commit a fraud against me.

This is actual and constructive notice that if you fail to obey the law, and continue to aid and abet the conspiracy via utilization of fraud and entrapment, to deprive me of my de jure State Citizenship and vested property rights, you will cause me further damage and injury. This will require whatever action deemed necessary and lawful to effect a remedy.

This instrument "ACTUAL AND CONSTRUCTIVE NOTICE", is hereby executed by service and delivery by certified mail, and as such shall be judicially noticed in any and all proceedings, legal or otherwise, that may be initiated for any and all reasons.
