Safe Erase can be installed on any computer which is capable of running Windows 3.x.

INTRODUCTION

Safe Erase is a windows trashcan utility to archive files. Archives are made by using windows drag and drop feature. Simply drag the file from the file manager and drop the file on Safe Erase program. Archive files are given unique names to allow for multiple copies of the original file. Safe Erase can compress the archive to minimize disk space.
