#### Search Path

This is the path currently searched by Zip Equalizer to locate Zipped files. This path can be modified/changed as needed. Seperate additional directories by semicolons (;). The Refresh Button must be pressed to update any changes made to the path.

## **Extend Window Button**

This button will extend the window so that you can see the Zip File Contents list box.

## Viewer Setup List Box

Lists all associtations currently saved. The format is Extention = Viewer.

## **Information Button**

Provides copyright information and access to this help file.

#### **Default Search Path**

Enter the Default Search Path you want Zip Equalizer to check each time it starts up. Each path is seperated by a semicolon (;).

Example: C:\CSERVE\DOWNLOAD;D:\AOL\DOWNLOAD;C:\PROCOMM\IN

## Add Button

Opens up the Add Viewer Spec Window which allows you to associate various viewers with file extensions.

#### **View Button**

The View Button will be active only when you have selected a file from the Zip File Contents List Box. To view a file it must have an associated viewer, see the Configuration Window for information on setting up associations.

#### **Working Directory**

This is the directory into which all operations with be performed. File Extractions will go into a subdirectory under the Working Directory. Files viewed with a viewer will be stored in the Working Directory and deleted upon the closing of ZipEqual.

## Extension Edit Box

Enter the three character (or less) extension you want to associate a viewer with.

Examples: TXT, DOC, INI, 1st, ME, BAT, etc...

#### Name of Viewer Edit Box

Enter the name of the viewer you want to associate with the previously entered file extension. If the viewer is not part of your path, then include the full path to the viewer.

Example: notepad.exe or winhelp.exe or psp.exe or c:\myviewer\viewit.exe

## Reduce Window Button

Reduces the Zip Equalizer Window back to it's startup size, effectively hiding the zip file contents section.

## Accept Button

Saves any changes you have made and returns you to the previous Window.

#### Contents of Currently Selected Zip File

List the content of the currently selected Zip File. Provides you with the file name, uncompressed size, time and date stamp of the file. You can double click on any file in this box that has an associated viewer to lauch the file into the viewer.

## Remove Button

Removes the currently highlighted association.

## Number of Items in Selected Zip File

Displays a count of the number of items found in the currently selected zip file.

#### **Extract Button**

Extracts the contents of the currently selected zip file into a subdirectory off of the Working Directory and names the directory with a Z for the first character and then first 7 characters of the zip file name (or characters up to the period).

Example: Original Zip file name is TURBOT.ZIP

Working Directory is C:\ZEQ\_WORK

Output Directory and name would be C:\ZEQ\_WORK\ZTURBOT

## **Cancel Button**

Cancels any changes made to the current Window and returns you to the previous Window.

## Options Button

Opens up the Zip Equalizer Configuration Window.

#### Zip File Listing

Lists all zip files found in the current Search Path. Seperates each path by a line showing the path and the quantity found. Single click on any file to expand the Window and view the contents of the zip file. Double click on any file to extract the file into it's own subdirectory under the Working Directory.

#### Refresh Button

When you update the Search Path from the Main Window you must click on the Refresh Button to update the Zip File List Box.



#### Using Zip Equalizer


Zip Equalizer is designed to simplify the process of unzipping files.
