Registering LogTick 3.1

LogTick 3.1 is a Shareware software package. This means that you're allowed to use LogTick 3.1 for an evaluation period of 30 days without paying. After the 30 day period, if you still want to use LogTick 3.1, you're obliged to register LogTick 3.1.

Costs

LogTick 3.1 costs f 35,- Dutch guilders, or \$ 25 US Dollars. Costs may vary according to the method of payment. See "**How to register ?**".

Why Registering ?

Because it's Shareware. Programming takes a lot of time. By purchasing Shareware software, you enable the author to provide new versions of shareware. So it helps you too. On top of that, extra functionality will become available, which is not available in the non-registered version.

How to register ?

If you're living in the Netherlands, and you're having a Dutch bank account:

1. Fill in the registration form, and EMAIL it to tmartens@pi.net
Don't forget to fill in your Bank Account number !
2. Wait until you get an acknowledgment reply from me via EMAIL
3. Transfer f 35,- in **Dutch guilders** to:

If you're living outside the Netherlands, but within Europe, and you have Euro-cheques

1. Fill in the registration form, and EMAIL it to tmartens@pi.net
Don't forget to fill in your Bank Account number (and cardnumber) !
2. Wait until you get an acknowledgment reply from me via EMAIL
3. Write an EuroCheque for **f 35,- Dutch guilders** (vijfendertig gulden) to:

4. As soon as I cashed the cheque, I'll send you your personal registration number through Email.

If you want to be on the save side with EuroCheques (so that nobody else than the Author can cash your cheque), don't write your card-number on the back of the cheque, but put the number in your registration form.

If none of the above applies:

1. Fill in the registration form, and EMAIL it to **tmartens@pi.net**
2. Wait until you get an acknowledgment reply from me via EMAIL

3a. When directly sending cash money:

*LogTick costs \$ 25 US dollars. the addition of \$ 12,- US dollars, is because of the costs that my bank will charge me for cashing and converting to Dutch guilders. If you want to avoid these extra costs, send me CASH \$ 25 US Dollars (paper-money ONLY) or f 35 Dutch guilders. **(see 3a)** or...

... if you register together with other users at the same time, you can use one international money order, and add just one time the additional \$ 12:

Example:

Register for 5 users: 5 x \$ 25

Additional costs: 1 x \$ 12

Intern.money order: \$ 137

In this example, the 5 users saved \$ 48, which is \$ 9.60 for each user.

4. As soon as

(3a) I received the money or

(3b) I cashed the cheque

I'll send you your personal registration number through Email.

What will happen then ?

You will receive a 10-digit registration number. With you first-name last-name this number is a valid combination which should be entered in the LogTick server program. This will enable register-only features.
