**1. DEFINITIONS**

"Ace Utilities " means the Ace Utilities software product and everything included in its official distribution packages, such as the documentation, all the plug-ins, and all other files.

"the Vendor" means the developer of the "Ace Utilities " software product, AceLogix Software.

**2. GRANT OF LICENSE**

The Vendor grants you the following rights provided that you comply with all terms and conditions of this license agreement:

1. Usage. You may install, use, access, display and run Ace Utilities in so many computers that the license you own allows you to.

**3. RESTRICTIONS AND LIMITATIONS OF USE**

You are NOT allowed to:

1. Modify, reverse engineer, decompile, disassemble or otherwise attempt to reconstruct or discover the source code, or any parts of it from the binaries of Ace Utilities.
2. Create, develop, distribute, use, install or store in your computer a program, source code, mechanism, method, protocol or algorithm to bypass or to brake Ace Utilities' features or license validation.
3. Remove any product identification, copyright, proprietary notices or labels from Ace Utilities.
4. Distribute, re-distribute, rent, lease or sell the licensed version of Ace Utilities or any portions of it or the license itself or any portions of the license without a written permission from the Vendor.
5. Distribute Ace Utilities in any other form than in the official distribution packages without a written permission from the Vendor.
