Your Personal Information

We are able to offer your Digimask free of charge as our business and revenues are generated from licensing the Digimask technology to those applications which support it, such as videogames, etc.

You are asked to enter some physical details about yourself. Please see our **Legal Notices** (below) to be reassured that this data is used to create a more accurate profile of you, the user and no information will be passed to any 3rd party without your permission.

Our Facial Recognition technology only works with human faces taken in the following poses. Submitting pictures of your pets, cartoon characters, etc simply will not be recognised and you will receive a message to that effect.

Remember that you have to agree to comply with the terms of our **User Agreement** (below) before you are able to submit your details. Most importantly, this states that:

- a) You are the person in the photograph (or their legal guardian if they are under 18); and
- b) You have the rights to use the photos.

Taking your photos - Do's and Don'ts

To get the best result, please observe the following suggestions:

Do's:



- Neutral expression
- No / minimal make-up
- Mouth closed, no smile
- Eyes open, looking ahead
- Hair back off face and behind ears
- Remove any spectacles (can be added later)
- Neutral light
- Plain background
- Photos correctly rotated
- One photo directly face-on
- One photo of perfect side profile
- The larger you are in the photo the better

Don'ts:



- No hats
- Avoid shadows on the face
- No more than one face in one photo
- A blurred photo is next-to-useless – the better the quality, the better the result.
- Avoid shadows on the background - stand away from it

Loading and Marking your photos

- 1) Ensure you know where you 2 photos are located
- 2) As suggested, use the 'Zoom' function ('+' and '-' buttons) to allow more accurate marking
- 3) Hold down the right mouse button to drag/move – the left button to mark the points
- 4) Pay close attention to where the flashing cursor on the example photo is – the point is also explained above the example photo.
- 5) On the Profile photo, please ensure your own picture is facing the same way as the Example. If not, use the 'Flip Image' button.

Submitting the data

On the last screen, you will be asked to submit the data previously entered. This process means you must be on-line to do so.

If you have a dial-up connection, then you must open this up before pressing 'Submit'. The simplest way of doing this, typically, is to open your Web Browser and go on-line.

If you access the Internet via a network connection, then going on-line should be automatic.

Loading and saving your data

On the first input screen, there is an option to load a previously-saved file. This means you needn't go through the entire process every time with the same person. Once you have completed all of the information (including the Photo input), then you are offered the opportunity to save the data locally on your hard drive. Very useful if you want to make a small correction – without having to go through the entire process again.

DIGIMASK USER AGREEMENT

IMPORTANT – Please read the following agreement carefully – the creation and use of your Digimask head will be governed by the terms set out below.

1. **Digimask Limited** – your Digimask head will be supplied by Digimask Limited of Diamond House, 179 Lower Richmond Road, Richmond, Surrey TW9 4LN United Kingdom (referred to in this Agreement as "we" or "us").

2. **Contract Formation**

A contract for the provision of your Digimask head will be created between us and you when we send you confirmation by email that we have accepted your order.

3. **Warranties from You**

You warrant to us that:

- 3.1 you are the person in the photograph that you are submitting to us; and
- 3.2 either you own all the rights in the photograph you are submitting or the person who took the photograph has been fully informed of how it will be used and has agreed to such use.

4. **Your Obligations**

You must:

- 4.1 only use your Digimask head with authorised Digimask enabled applications, whether games, websites or other applications. Authorised applications display the Digimask logo. If you are in any doubt as to whether an application is authorised check [the list on the Digimask site](#);
- 4.2 keep your Digimask head and your Digimask password secure at all times - your password and Digimask head should only be provided, as necessary, to providers of authorised Digimask enabled applications which you wish to use;
- 4.3 not use your Digimask head other than for your own personal, non-commercial purposes;



- 4.4 respect any minimum age or other restrictions which are imposed by the providers of any Digimask enabled application; and
- 4.5 not copy, reverse engineer or decompile your Digimask head or any Digimask enabled application, save as permitted by law.

5. Privacy & Security

5.1 We will not use or disclose any information you provide to us in this form, or which you update via our website, except as set out in this Agreement. However, you are responsible for your Digimask head and should treat it with care and only provide it and your password to authorised application providers whom you trust.

5.2 We will use:

- 5.2.1 the photograph, name, date of birth, gender, physical statistics and generic model choices you provide to us in order to create your Digimask head. This information and your country of residence will also be encoded into your Digimask file;
- 5.2.2 the information referred to at clause 5.2.1 above plus your email address, preferred language and how you intend to use the Digimask head for administrative purposes and anonymised statistical analysis.

5.3 We will make your Digimask head available to authorised application providers to whom you provide your password. These authorised application providers (and any other persons to whom you directly disclose your Digimask head) will be able to read the information referred to at clause 5.2.1 above, which is encoded into your Digimask head. Having such information enables application providers to fully implement your Digimask head in their applications.

5.4 We may also from time to time pass certain of the information you provide to us to third parties, for a particular purpose but we will only do this if you have consented to such disclosure.

5.5 We reserve the right, at our discretion, to reveal any or all of the information you provide to us to third parties if we suspect that you have breached the terms of this Agreement.

6. Rights in your Digimask head

7. Termination
