The Sound-Trecker V2.0 consists of four major parts:

- the Sound-Trecker V2.0 application program;
- the documentation (this Licence Agreement, the User Manual, the Programmer's Guide, and the 'XFCN' Manual);
- the Sound-Trecker V2.0 drivers (contained in the 'PSTk', 'ISTk', and '©STk' resources);
- the C interface to the Sound-Trecker V2.0 drivers (C libraries, sample source codes);
- the Sound-Trecker V2.0 'XFCN'.

All parts belong to the author. They may not be used, copied or altered in any way without the author's written permission, except in those cases explicitly permitted in this licence agreement.

Copying the Program

“The Sound-Trecker V2.0” application is a shareware product. You are permitted and encouraged to copy the application program and the C interfaces, and to give them freely to anyone, provided the program is copied in its entirety, including this licence agreement and the respective manual. You may not alter the program in any way (if you find bugs, please tell me to fix them).

Using the Sound-Trecker Application

Using the Sound-Trecker application means running the application program in order to listen to '.MOD' files. If you want to use the Sound-Trecker application in a non-commercial way, please pay a shareware fee of \$30 to the author (at the address shown above). If you can't afford it, pay \$20. If this is *still* too much, then just pay the formal amount of one dollar, but send me a souvenir of yourself or your home town, for example:

- a local newspaper (please German or English only)
- an autograph plus photo of yourself (in case you are a V.I.P.)
- an autograph plus photo of a local politician (e.g. the mayor)
- a town map and tourist information of your home town
- a prospectus of your university (if you are a student)
- a McDonald's credit bill
- a disk with many many new '.MOD' files

- etc. (well, think of something yourself)

Of course, it is up to you to pay more. For those who have already paid the shareware fee for the Sound-Trecker *V1.0*, using V2.0 is free.

For commercial *use* of the application program, the fee is \$50. This applies to Apple dealers, too.

Including the Sound-Trecker Drivers in Your Own Software

The Sound-Trecker Drivers can easily be included in your own software. Playing a '.MOD' file requires only a few simple calls, as shown in the sample program “Simple Trecker”. Including the Drivers (contained in the 'PSTk', 'ISTk', and '©STk' resources), the C interface libraries, or parts of “Simple Trecker.c” in public domain software or freeware is free under the following conditions:

- any program using the drivers, as well as its documentation, must contain a copyright note about the three resources and the interfacing code, including my address (as given above);
- a copy of the program has to be sent to me;
- altering the code is forbidden;
- use in programs capable of editing the notes of a '.MOD' file is forbidden;
- the program may not enable multimedia or presentation software to use the Sound-Trecker drivers (such as HyperCard 'XFCN's);

A commercial use of the drivers requires my explicit written agreement, and usually an individual licence.

Translating the Sound-Trecker Application

The Sound-Trecker application is currently available in German and English. A translation into any other language, which can be performed easily using ResEdit, is permitted under the following conditions:

- the translation must be free of charge for the user;
- it must be complete, including all menus ('MENU'), dialogs/alerts ('DITL', 'ALRT'), all error messages ('STR#'), Balloon Help ('hdlg', 'hmnu'), and all special resources (like 'mst#' etc.);
- a copy has to be sent to me.

Of course, the translator may add his own name and address where appropriate (i.e. in the 'vers' 1 and the 'STrk' 0 resource, the “About” alert, or in a “readme” file).
