BEFORE USING THE TRAINING PRODUCT, CAREFULLY READ THE FOLLOWING:

IMPORTANT: NATIONAL EDUCATION TRAINING GROUP, INC. ("NETG") IS WILLING TO LICENSE THE ENCLOSED TRAINING PRODUCT TO YOU ONLY ON THE CONDITION THAT YOU ACCEPT THE TERMS AND CONDITIONS CONTAINED IN THIS LICENSE AGREEMENT. BY USING THE TRAINING PRODUCT, YOU AGREE TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PROMPTLY RETURN THIS TRAINING PRODUCT AND ALL ACCOMPANYING ITEMS TO THE PRODUCT PROVIDER FOR A FULL REFUND OF THE LICENSE FEE YOU PAID.

1. Grant of License. In exchange for the fees paid in accordance with your order, National Education Training Group, Inc. ("NETG") hereby grants you a nonexclusive license to use the enclosed Training Product for the sole purpose of training. This Training Product may be installed and used on the hard drive of any single computer for use by one user. If additional users wish to use the Training Product, a copy of the Training Product must be licensed by each additional user. If you wish to use the Training Product on more than one computer, you must either erase the Training Product from the first hard drive before you install it onto a second hard drive, or else license an additional copy of the Training Product for each additional computer on which the Training Product will be used.
2. Copyright and Proprietary Rights. The Training Product is owned by NETG or its suppliers and is protected by United States copyright laws and international treaty provisions. Therefore, you may not reproduce, copy, broadcast, publicly perform or display, network, modify, alter, decompile, or reverse engineer the Training Product. NETG or its suppliers retain all rights not expressly granted to you in this license agreement.
3. Other Restrictions. This Single Learner License Agreement is your proof of license to exercise the rights granted herein and cannot be transferred. Therefore, you may not sell, lease, rent, lend or permit the use of the Training Product by others.
4. Limited Warranty. NETG warrants that, for ninety days following delivery, the Training Product will perform substantially in accordance with its documentation, and NETG warrants that it has title to, or the right to license, the Training Product provided to you. If the Training Product fails to comply with any of these warranties, NETG will use reasonable efforts to correct the noncompliance (by, for example, providing to you a modification or replacement of the Training Product) following the time you notify NETG

of the problem. In the event that NETG is unable to correct the noncompliance, NETG will refund to you an equitable portion of the price you paid to license the Training Product, in full satisfaction of your claims and damages. THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

5. Limitation of Liability. TO THE EXTENT PERMITTED BY APPLICABLE LAW, NETG's LIABILITY TO YOU SHALL BE LIMITED TO DIRECT DAMAGES, AND SHALL NOT EXCEED THE AMOUNT YOU PAID FOR THE TRAINING PRODUCT.
