

Berkeley Data Systems License and Service Agreement

IMPORTANT: READ THIS AGREEMENT CAREFULLY BEFORE CLICKING ON THE “ACCEPT” BUTTON BELOW.

This agreement (the “Agreement”) is a legal agreement between you, either an individual or a single legal entity (“You” or “you”), and Berkeley Data Systems Inc. (“Berkeley Data Systems”). This Agreement governs your use of the Berkeley Data Systems Mozy Backup Client software distributed with this Agreement, including any updates that may be provided to you and any accompanying written documentation (the “Software”) and the Berkeley Data Systems Mozy backup service (“Service”).

By clicking “ACCEPT” you are indicating that you have read and understood, and assent to be bound by, the terms of this Agreement. If you are an individual working for a company, you represent and warrant that you have all necessary authority to bind your company to the terms and conditions of this Agreement.

If you do not agree to the terms of the Agreement, you are not granted any rights whatsoever in the Software or any right to receive the Service.

If you are not willing to be bound by these terms and conditions, you should not click “ACCEPT” and must return or destroy all copies of the Software promptly for a full refund.

FREE SERVICE; ADVERTISING EMAILS

You acknowledge and agree that Berkeley Data Systems may provide you with advertising and promotional material and other information from Berkeley Data Systems and on behalf of third parties via email. If you do not want to receive such material, you may elect not to do so, but you must immediately terminate your account and cease use of the Software and Service. This Agreement applies exclusively to Software and Service that are provided by Berkeley Data Systems without charge.

ACCOUNTS, PASSWORDS, AND SECURITY

You must be a registered user to access the Service. You are responsible for keeping your password secure. You will be solely responsible and liable for any activity that occurs under your user name. If you lose your password or the encryption key for your account, you may not be able to access your Data.

ACCEPTABLE USE AND CONDUCT

You are solely responsible for your conduct and your data related to the Service. You agree to indemnify, defend, and hold harmless Berkeley Data Systems and its suppliers from any and all loss, cost, liability, and expense arising from or related to your data, your use of the Service, or your violation of these terms.

The Software and Service are made available to you only for your personal use, which use must be in compliance with all applicable laws, rules and regulations and must not infringe or violate third party rights. CONSENT TO COLLECT NON-PERSONAL INFORMATION; USE OF DATA

The Software and Service may collect certain non-personally identifiable information that resides on your computer, including, without limitation, statistics relating to how often backups are started and completed, performance metrics relating to the Software, and configuration settings. This information collected will be sent to Berkeley Data Systems and may be used by Berkeley Data Systems without restriction.

When you backup data via the Service, you agree that we and our service providers may copy and store such data as part of the Service.

CHANGES TO THE SERVICE AND TERMS AND CONDITIONS

Berkeley Data Systems reserves the right at any time to modify, suspend, or discontinue providing the Service or any part thereof in its sole discretion with or without notice.

Berkeley Data Systems will use commercially reasonable efforts to notify you of modification, suspension, or discontinuance of the Service either by sending an email to the email address you provide with your registration or by a posting on Mozy.com website. However, in no event will Berkeley Data Systems be liable to you or to any third party for any modification, suspension or discontinuance of the Service with or without notice.

Berkeley Data Systems reserves the right at any time to modify this Agreement in its sole discretion, without liability to you. This Agreement, as amended, will be effective upon acceptance of registration for new users and effective for all existing users 15 days after the posting of any amended terms on the Mozy.com website. TERM AND TERMINATION

This Agreement is effective until terminated.

You may terminate this Agreement at any time by destroying the Software and closing your account by following the instructions on the Mozy.com website.

This Agreement automatically terminates if you fail to comply with its terms and conditions. Berkeley Data Systems reserves the right to refuse or discontinue participation to any user at any time at its sole discretion.

You agree that, upon such termination, you will destroy and permanently erase all copies of the Software and that your access rights to the Service will immediately terminate.

The terms of the Sections entitled Prohibited Actions, Consent to Collect Non-Personal Information, Intellectual Property, Feedback, Disclaimer of Warranties, Limitation of Liability, and Miscellaneous will survive expiration or termination.

If this Agreement terminates, other than for your failure to comply, Berkeley Data Systems will use commercially reasonable efforts to make your Data available for you to download for a period of **three (3) days**. Berkeley Data Systems has no obligation to provide you with a copy of your Data and may remove and discard any Data.
