Alteration of Licensed Products: Licensee agrees not to remove or destroy any copyright notices from the Licensed Product(s) or its documentation. Licensee may not alter the Licensed Product(s), with the exception of modifying Macintosh[®] resources under the direction of the Licensor to customize the appearance or behavior of the product(s).

Distribution of Licensed Products: Licensee may distribute modified versions of the Licensed Product(s), subject to the foregoing limitations, up to the total number of units listed on the first page of this agreement. Unaltered copies of shareware products may be distributed to any individual or organization, subject to the distribution restrictions and shareware agreements specified in the documentation for the products.

Support for Licensed Products: The Licensor will make available reasonable amounts of telephone, mail, or fax consultation regarding the Licensed Product(s). Limited Warranty:

- a. The Licensor warrants that it that it has the right to license the use of the Licensed Product(s).
- b.
