Registration

This will afford you a Single-machine licensing. This allows you to use

Payroll Master 2.0 on any ONE machine at any time. For example, one copy may be used by any number of people and may be freely moved between computers, as long as there is no chance of the program being used simultaneously on more than one machine.

To request a site license, send a letter specifying your organization's name and address as they should appear on the license

contract, and indicate the number of machines you wish to have covered by the license. You will receive two copies of the site license which must be signed and returned along with the license fee. An authorized copy of the contract will then be mailed to you.
