Using Button Magic

Button Magic is a program that will allow you to create buttons in no time at all for your website. With button magic you don't need to be a graphic wizard. Let Button Magic do the work for you while you get the credit.

The Shareware version of Button Magic will not time out or anything. You just will not be able to export to gif format unless you register Button Magic for \$10US.

Using button magic is simple just set up the button properties and away you go. It is best to play with the different settings. Once you are happy with the way your button looks just save it. Or create multiple buttons at one time by going to the file menu and Multiple Export. Its that easy:)
