## **Summary of Features**

- **Print your own BINGO cards.** Options are provided to print large 1 card per page, down to tiny 16 cards per page. Add your own header and footer to each page (*registered version only*). Each card is automatically randomized. An option to "keep the numbers ordered" is provided. This feature can be used to make "easy cards" for small children.
- **Randomized ball selection.** There is no way to predict or control which ball will be called next. Advanced randomization techniques are used to insure a fair game every time.
- **On screen call tray.** See which balls have already been called. Watch the balls move into the tray as they are called.
- **Adjustable calling speed.** Use the slider control to set the automatic calling speed from 5 seconds (very fast), down to a leisurely 30 seconds between calls.
- **Manual calling.** The automatic call timer can be turned off, and you can control when a ball is called by clicking "Call Now". "Call Now" can also be used when the timer is set to a slow speed.

- **Multiple game modes.** Settings are provided for various games (big diamond, little diamond, etc.) When used, only the letters that are needed for the game type selected will be called. You can also enable or disable each individual letter.

- **Voice selection.** Choose from the supplied male or female voices. Voices can be turned off, or multiple voices can be selected to randomly alternate between the selected voices.

- **Custom voice files.** Create your own custom talking voice files. Imagine the fun of having your favorite Aunt call your games for you - a Treasure to keep forever!!! *This feature requires the registered version of the program.*

- **Sound effects.** Tumbling ball sounds, and ball drop, provide a realistic BINGO machine effect. The sounds can be turned off.

- **Automatic game recovery.** As each ball is called, the current game status is saved on disk. If a power failure or system crash occurs, you will have an opportunity to resume the game that was in progress at the exact point of interruption.
