

## **Purpose**

Grammar Reference is a program to provide a convenient and quick reference to US English grammar usage.

## **Using Grammar Reference**

Grammar Reference is designed to be used in conjunction with your word processor or text editor, but it does **not** make any changes to other programs.

When Grammar Reference is run for the first time on your system, it will create a small window in the lower right hand corner of your screen. This minimizes the amount of the screen that is used by Grammar Reference.

The window can be re-sized to display some or all of the 21 buttons which provide access to the grammar example text. However, this unnecessarily takes up screen space since the 21 menu selections under Index provide the same access.

## **Menu Options**

Grammar Reference has three main menu selections, Index, Config and About GR.

### **Index**

Selecting the Index option will display a pop-up menu containing 21 selections arranged alphabetically, except for the 21st selection which is Sources. The 21 selections are the same as the 21 buttons. Selecting one of the options will display an appropriate text window. The text window can be moved and re-sized, but the program will not save settings for the text window.

### **Config**

Selecting the Config option will display a pop-up menu containing 4 options:

- 1) Normal Color. Selecting this option will display a standard Windows Color Selection dialog.
- 2) Highlight Color. Selecting this option will display a standard Windows Color Selection dialog.
- 3) OnTop Status. Selecting this option will enable or disable the ability of Grammar Reference and it's open text window to remain on-screen if you switch to another program.
- 4) Save Settings. Selecting this option will save the current size and position of the Grammar Reference window, as well as the Normal and Highlight color values and the OnTop Status value. The values will be saved in a file named GR.INI in your windows directory.

### **About GR**

Selecting About GR will display a pop-up Dialog containing some informative text.

Grammar Reference is shareware. The registration fee is \$5.00 (US). Payment of the registration fee entitles you to use of any future version of Grammar Reference released by Richard C. Waite, Jr.
