AMYUNI CONSULTANTS DEVELOPER'S LICENSE AGREEMENT FOR AMYUNI PDF CONVERTER / PDF COMPATIBLE PRINTER DRIVER

NOTICE TO USER:

THIS IS A CONTRACT. BY INSTALLING THIS SOFTWARE YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT.

This AMYUNI Consultants ("Amyuni") Developer License Agreement accompanies the PDF Compatible Printer Driver and related explanatory materials ("Software"). The term "Software" also shall include any upgrades, modified versions or updates of the Software licensed to you by Amyuni.

Please read this Agreement carefully. You will be asked to **accept** this agreement and continue to install or, if you do not wish to accept this Agreement, to **decline** this agreement, in which case you will not be able to use the Software.

Upon your acceptance of this Agreement, Amyuni grants to you a nonexclusive license to use the Software, provided that you agree to the following:

1. Use of the Software. You may include the Software as part of your own applications to install it on your client's machine at the same time as your own applications, as long as your applications' main purpose is not the generation of PDF files. You may also include the Software in your in-house applications applications, as long as your applications' main purpose is not the generation of PDF files.

2. Copyright and Trademark Rights. The Software is owned by Amyuni, and its structure, organization and code are the valuable trade secrets of Amyuni. The Software also is protected by Canadian Copyright Law and International Treaty provisions. This Agreement does not grant you any intellectual property rights in the Software.

3. Restrictions. You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Software. You may not sell the product as a standalone application. You will make all necessary steps to prevent users of your applications to use the Software other than from inside your applications.
