General Instructions

This puzzle was invented in the late nineteenth century by Edouard Lucas, a French mathematician.

The object is very simple. You are given a pattern, two sets of colored markers, with an empty space in the middle. You have to reverse the pattern.

Just to keep it interesting, there are a few rules on how you can go about this. The markers can only be moved in one direction, red markers toward the right, and blue marker toward the left. Second, a marker can only be moved to the empty space by either sliding it over to the adjacent square, or by jumping over one other marker.

Using A Mouse



To move a piece, just click on it's box. The mouse cursor will be a cross-hair over those piece which can be legally moved.

Using The Keyboard

When the game starts, the arrow cursor is placed on the center (empty) square. Using the left and right arrows will position the cursor over any of the squares.

On those which can be legally moved, the cursor will appear as a cross-hair. Press Enter to move the piece.

Alternately, you can use the digit keys. Each piece is numbered. Press the appropriate key to move a piece.

Making "Lucas" Talk

For its latest incarnation, "Lucas's Puzzle" has sound effects which can optionally accompany the play of the game.

To use this feature, choose the "Change Voice" item on the "Options" menu. Then from the dialog box, select the correct configuration for your system. Most of the options are various sounds products by Covox, Inc. However, there is an option for using the internal speaker.

You can also disable the feature entirely by choosing the "No Sound" option.

There is a "Test" button, which has a human voice speaking a sentence output to the selected device.

Choosing this option displays an Dialog box, which allow you to select the sound output options. You may choose from several different products designed by Covox, Inc; or to use the Internal Speaker of your computer; or to turn off the sound feature entirely.

Show Win

Choosing this option will cause the game board to quickly play through a game to a win, proving to all of you that it really can be done. The display is a bit slower (and more visible) with a sound option on.

This program was inspired by a BASIC version written by William L. Colsher, and published in Kilobaud Magazine, in November 1979. The programs themselves aren't remotely similar.

The sound generating routines were produced by Covox, Inc of Eugene, Oregon, for use with their Voice Master and Speech Thing products. They were nice enough to include support for the internal speaker also.

I am not connect with Covox in any way.

The digitized sounds were taken from presumably Public Domain MacIntosh sound files.
