BY INSTALLING AND USING THE SOFTWARE, YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. 1. Definitions

- (d)"Software" means the Universe Web Browser® software program supplied by Solarbaybies Inc. herewith, which may also include documentation, associated media, printed materials, and online and electronic documentation and content delivery. The term "Software" also includes the Universe Instant Messenger, Brain, Pilot, Safari, and Radio software programs supplied by Solarbaybies Inc. herewith in conjunction with the Solarbaybies Inc. 2. License

This EULA allows you to:
