

MRT RESEARCH LICENSE AGREEMENT FOR INTELLIPointer SOFTWARE

READ THIS AGREEMENT BEFORE COPYING, INSTALLING OR USING INTELLIPointer.

This is a Software License Agreement for IntelliPointer. IntelliPointer includes the Executable File and any related materials.

By installing IntelliPointer, you agree to the terms of this Agreement.

LICENSE

You may install and use one copy of IntelliPointer on a single computer.

You may not copy or modify IntelliPointer.

You may not rent, sell, sublicense, distribute or transfer IntelliPointer or any part thereof.

You agree to prevent unauthorized copying of IntelliPointer.

You may not reverse engineer, decompile, or disassemble IntelliPointer.

If you have purchased IntelliPointer with Multiple Licensing, you may install and use additional copies of IntelliPointer up to the number of copies specified in the Multiple Licensing.

You may use or keep any trial version of IntelliPointer only for a period of one month.

OWNERSHIP AND COPYRIGHTS

MRT Research owns the title to all copies of IntelliPointer. IntelliPointer is copyrighted and protected by the laws of the United States and international treaties. You may not remove any copyright notices from IntelliPointer. MRT Research may make changes to IntelliPointer without notice. MRT Research is not obligated to support or update IntelliPointer. MRT Research grants no rights under MRT Research patents, copyrights, trademarks, or other intellectual property rights.

MEDIA WARRANTY

If IntelliPointer has been delivered by MRT Research on physical media, MRT Research warrants such media to be free from physical defects for a period of ninety days from delivery thereof. If such a defect is found, return such media to MRT Research for replacement.

EXCLUSION OF OTHER WARRANTIES

Except the above, IntelliPointer is provided "as is" without any express or implied warranty of any kind including warranties of merchantability, noninfringement, or fitness for a particular purpose.

LIMITATION OF LIABILITY

In no event shall MRT Research or its suppliers be liable for any damages, including lost profits, business interruption, or lost information arising out of the use of or inability to use IntelliPointer, even if MRT Research has been advised of the possibility of such damages. Some jurisdictions prohibit exclusion or limitation of liability for implied warranties or consequential or incidental damages, so the above limitation may not apply to you. TERMINATION OF THIS AGREEMENT
