

**NetManage First Look Sample and Nondisclosure License Agreement (for samples of the prerelease product currently known as Chameleon Internet SDK, the "SOFTWARE" and for its related documentation, the "Documentation").**

**DO NOT USE THE SOFTWARE UNTIL YOU HAVE READ THIS LICENSE AGREEMENT ("License").**

**BY INSTALLING THE SOFTWARE OR AUTHORIZING ANY OTHER PERSON TO DO SO, YOU ACCEPT THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, YOU MAY RETURN THE PRODUCT (as hereafter defined) BY FAILING TO RETURN THE PRODUCT WITHIN TEN DAYS AFTER RECEIPT, YOU ACCEPT THE TERMS OF THIS AGREEMENT.**
