## **Properties**

Manages the server properties of the selected computer. Use this command to display a summary of connections and resource use; to view a list of connected users, shared resources, and open resources; and to manage the computer description, directory replication, the logon script path, and the list of administrative alert recipients.

## **Shared Directories**

Manages shared directories on the selected computer. A shared directory can be accessed by network users. Use this command to share, stop sharing, modify properties, and manage permissions for shared directories.

## **Services**

Manages services. Use this command to stop, start, pause, continue, pass startup parameters to, and configure startup for services.

## **Send Message**

Sends your message to all users connected to the selected computer.

For a message to be sent and received, the Messenger service must be running on the computer sending the message and on the computers receiving the message.

## **Promote To Domain Controller**

Promotes the selected server to domain controller. If it is available, the previous domain controller is automatically demoted to server status.

This command is only available when Server Manager displays a domain, and a server is selected.

## **Demote to Server**

Usually, when a server is promoted to domain controller no special action needs to be taken to demote the former domain controller to server status, because the system does this automatically.

However, if a server is promoted to domain controller while the existing domain controller is unavailable (for example, if it is being repaired), and if the former domain controller later returns to service, you must demote it.

When a former domain controller returns to service under this circumstance, and is selected in the Server Manager window, the Promote To Domain Controller command becomes the Demote To Server command. Until it is demoted the former domain controller does not run the Net Logon service, does not participate in authenticating user logons, and in the Server Manager window its controller icon is dimmed.

## **Synchronize with Domain Controller**

This command is only available when a server is selected.

When a Windows NT Advanced Server is selected, this command replicates the domain's security database from the domain controller to that server. When a LAN Manager 2.x server is selected, this command reestablishes the server's computer account password between that server and the domain controller.

Synchronization is usually done automatically by the system, but if the security database on a Windows NT Advanced Server becomes unsynchronized, or if a LAN Manager 2.x server is unable to establish network connections, this is a manual way to correct the situation. It is rarely necessary.

## **Synchronize Entire Domain**

This command is only available when the domain controller is selected. It replicates the domain's security database from the domain controller to all the servers in the domain.

This is usually done automatically by the system, but if the security databases become unsynchronized, this is a manual way to correct the situation. It is rarely necessary. It can take a substantial amount of time to complete.

## **Add to Domain**

Before a Windows NT workstation or a Windows NT Advanced Server can be a domain member and participate in domain security, it must be added to the domain. Computers that are added to a domain are given accounts in the domain's security database. There are three ways to add computers to a domain, but only one of them requires Server Manager. That method uses the Add To Domain command.

- A workstation can be added to a domain during installation of Windows NT, and a server can be added to a domain during installation of Windows NT Advanced Server, but only when the installations are performed by an Administrator.
- An Administrator can add an existing Windows NT workstation to a domain using the Network option of that workstation's Control Panel.
- Or, an Administrator or an Account Operator can use Server Manager's Add To Domain command to add a computer account to the domain's security database. Then the computer's user must have the computer join the domain under that computer account. This can be accomplished by a user as part of workstation or server installation; or, for a workstation, after installation by using the Network option in Control Panel.

Note: Treat the added computer name as a security element. Until the intended computer joins the domain, it is possible for a user to give a different computer that computer name, and then have it join the domain using the computer account you have just created. If the added computer is a server, when it joins it receives a copy of the domain's security database.

## **Remove from Domain**

Removes the selected computer from the domain. The computer's account is deleted from the domain's security database, and it can no longer participate in domain security.

The domain controller cannot be removed.

## **Servers**

Displays only servers in the Server Manager window. Workstations are filtered from the display, and are not shown.

When Servers is enabled, a check is displayed on the View menu to the left of the command, and (Servers) appears on the Server Manager title bar.

## **Workstations**

Displays only workstations in the Server Manager window. Servers are filtered from the display, and are not shown.

When Workstations is enabled, a check is displayed on the View menu to the left of the command, and (Workstations) appears on the Server Manager title bar.

## **All**

## **Show Domain Members Only**

By default, the list of computers displayed in the Server Manager window contains computers that are members of the domain, plus computers that the Computer Browser service reports as active on the domain.

The Show Domain Members Only command filters the display so that the list is composed of only those computers that are members of the domain. When this command is enabled, a check is displayed on the View menu to the left of the command.

## **Refresh**

When Server Manager starts, and every time the Select Domain command is issued, Server Manager receives information necessary to create the computer list displayed in the Server Manager window. The information is refreshed (updated with current data) after some other Server Manager functions, such as changing computer properties, managing services, or promoting a server to domain controller. (These refreshes do not occur when the Low Speed Connection option has been selected.)

A refresh can be initiated by a user, using the Refresh command from the View menu.

## **Low Speed Connection**

When administering a domain, workgroup, or computer that communicates with your computer across a connection providing relatively low transmission rates, choose the Low Speed Connection option. This prevents automatic refresh of the Server Manager screen, which may be time consuming when performed across low speed connections. (Refreshes occur automatically after some Server Manager functions, such changing computer properties, managing services, or promoting a server to domain controller.) When this option is enabled, a check is displayed on the Options menu to the left of the command.

In Low Speed Connection mode the Server Manager screen can still be refreshed manually by choosing the Refresh command from the View menu.

Low Speed Connection can also be selected (or cleared) from the Select Domain dialog box, at the same time you select a domain, workgroup, or computer to be displayed by Server Manager.

## **Save Settings On Exit**

When you quit Server Manager, if the Save Settings on Exit command from the Options menu is enabled (indicated by a check to the left of the command) the main window size and position and the View menu settings are saved.

## What Is Server Manager?

Server Manager is a tool you can use to manage domains and computers. With Server Manager you can:

- Select a domain, workgroup, or computer to be administered.
- Manage a computer For a selected computer you can view a list of connected users, view shared and open resources, manage directory replication, manage the list of administrative alert recipients, manage services and shared directories, and send messages to connected users.
- Manage a domain. When administering a domain you can promote a server to become the domain controller, synchronize servers with the domain controller, and add computers to and remove computers from the domain.

Some of the capabilities offered by Server Manager are also offered by the Services and Server options in the Control Panel of every Windows NT computer. However, Server Manager can manage both local and remote computers, while these Control Panel options only affect the local computer.

## The Server Manager Window

In most cases, when Server Manager is first started it displays your logon domain. The Server Manager title bar shows the domain name, and the body of the Server Manager window lists the computers of that domain. A computer can be selected from this list, and can then be managed using commands from the Computer menu.

**Title bar**

The title bar of the Server Manager window names the domain, workgroup, or computer that is displayed for administration.

When filtering is enabled using commands from the View menu, a notation of (Servers) or (Workstations) is displayed on the title bar to the right of the domain, workgroup, or computer name.

## **Menu bar**

The menu bar contains four menus.

- **Computer.** Commands from this menu are used to view and manage domains, workgroups, and computers.
- **View.** Commands from this menu are used to filter the displayed list of computers, to remove filtering, and to update Server Manager with current information.
- **Options.** Commands from this menu can select or clear the Low Speed Connection and Save Settings on Exit options.
- **Help.** Commands from this menu provide online Help.



## **List of computers**


The body of the Server Manager window lists the computers of the domain selected for administration (that is, the domain whose name is displayed in Server Manager's title bar). This list contains computers that are members of the domain, plus computers that the Computer Browser service reports as active in the domain.


The list can contain these kinds of computers: Windows NT Advanced Servers, Windows NT workstations that are running the Server service, and Microsoft LAN Manager servers. Microsoft Windows for Workgroups computers might also appear in the list, but because they do not support remote administration they cannot be administered with Server Manager.


When a Windows NT workgroup is selected for administration, the computers of that workgroup are listed. When an individual computer is selected for administration, only that computer is listed. The list of computers can be filtered using commands from the View menu.

## Computer icons

An icon graphically indicates the type of each listed computer.

 Controller. Maintains the domain's security database, and authenticates network logons.

 Server. Receives a copy of the domain's security database, and authenticates network logons.

 Workstation. Any other listed computer.

If a computer does not support remote administration, or if it is unavailable to the network (for example, if it is turned off), its icon is dimmed.

**Computer column**

For each listed computer, this column provides the computer name.

**Type column**

For each listed computer, this column states the operating system, the version number of the operating system, and whether the computer is a controller, server, or workstation.

For example, a computer might be shown as a Windows NT 3.10 Server.

If a computer does not support remote administration, or if it is unavailable to the network (for example, if it is turned off), the version number is absent from this column.

## **Description column**

For each listed computer, this column might contain descriptive text or it might be blank.

For each listed computer, the description is an optional entry. It can be edited using the Properties command from the Computer menu. It might typically contain such information as the location of the computer, the name of the computer's user, the user's telephone extension, the brand or model of the computer, or a description of the computer's function.

If a computer does not support remote administration, or if it is unavailable to the network (for example, if it is turned off), its description is blank.

## **Who Can Use Server Manager?**

To use Server Manager to administer a domain and its servers, you must be logged on to a user account that is a member of the Administrators, Domain Admins, or Server Operators group for that domain. Members of the Account Operators group can also use Server Manager, but only for the purpose of adding computers to the domain.

To use Server Manager to administer a Windows NT workstation, you must be logged on to a user account that is a member of the Administrators or Power Users group for that workstation.

A few Server Manager functions are only allowed for Administrators or Domain Admins. When Server Operators, Account Operators, or Power Users attempt to perform these functions, a message is displayed indicating that access is denied.

## Selecting a Domain

In most cases, when Server Manager starts it displays your logon domain. Use the Select Domain command to display a different domain, a Windows NT workgroup, or an individual computer.

A *domain* is a collection of computers that are grouped for viewing purposes and that share a common security database. A *workgroup* is a collection of computers that are grouped only for viewing purposes.

### To change the domain displayed by Server Manager

1. From the Computer menu, choose Select Domain.
2. Select a domain from the list in the Select Domain list box, or type a *domainname* in the Domain box.

Optionally, to specify a Windows NT workgroup instead of a domain, type a *workgroupname* in the Domain box. To specify an individual computer, type the \\ *computername* (precede computer names with two backslashes).

3. If the domain, workgroup, or computer you have specified communicates with your computer over a low speed connection, select the Low Speed Connection option.

The system saves the setting of this option for each of the last 20 domains, workgroups, or computers you have administered. After you specify a name, the previous setting of this option (if any) is initially displayed here. If no previous setting is known, the option is initially cleared. You can accept or change the setting.

4. Choose the OK button.

## **Displaying Servers, Workstations, or Both**

By default, the list of computers in the Server Manager window includes both servers and workstations. Optionally, you can filter the list and display only one of those types.

### **To display only servers**

- ▶ From the View menu, choose Servers.  
A notation of (Servers) is displayed on the title bar, and on the View menu a check is displayed to the left of the Servers command.

### **To display only workstations**

- ▶ From the View menu, choose Workstations.  
A notation of (Workstations) is displayed on the title bar, and on the View menu a check is displayed to the left of the Workstations command.

### **To display both servers and workstations**

- ▶ From the View menu, choose All.



## **Displaying Domain Members Only**

By default the list of computers displayed in the Server Manager window contains those computers that are members of the domain, plus those computers that are listed by the Computer Browser service as active in the domain. Optionally, you can filter the list to display only those computers that are members of the domain.

### **To display only those computers that are members of the domain**

- ▶ From the View menu, choose Show Domain Members Only.  
A check is displayed on the View menu, to the left of the Show Domain Members Only command.

### **To remove filtering and display all computers**

- ▶ From the View menu, choose Show Domain Members Only.  
The check at the left of the Show Domain Members Only command is removed.

The information is refreshed (updated with current data) after some Server Manager functions, such as changing computer properties, managing services, or promoting a server to domain controller. ## Using Low Speed Connection

When administering a domain, workgroup, or computer that communicates with your computer across a connection providing relatively low transmission rates, use the Low Speed Connection option. This prevents automatic refresh of the Server Manager screen, which may be time consuming when performed across low speed connections. (Refreshes occur automatically after some Server Manager functions, such as changing computer properties, managing services, or promoting a server to domain controller.)

Here are two ways to select or clear the Low Speed Connection option:

- When you have chosen the Select Domain command from the Computer menu and you are selecting a domain, Windows NT workgroup, or computer to be displayed by Server Manager, you can select or clear the Low Speed Connection option in the Select Domain dialog box.
- When a domain, Windows NT workgroup, or computer is already displayed by Server Manager, you can select or clear the Low Speed Connection option by choosing the Low Speed Connection command from the Options menu.

The system saves the setting of the Low Speed Connection option for each of the last 20 domains, workgroups, or computers you have administered. After you specify a name in the Select Domain dialog box, the previous state of this option (if any) is initially set. You can accept or change this setting.

If you have not previously administered the specified domain, workgroup, or computer, and if you do not select the Low Speed Connection option in the Select Domain dialog box, after you choose the OK button the system automatically determines the appropriate connection mode and selects or clears the Low Speed Connection option accordingly. After connection you still have the option of changing the setting by using the Low Speed Connection command from the Options menu.

Also, when starting Server Manager from the command prompt, you can optionally append the low speed connection parameter **[/l]** or the normal (high speed) connection parameter **[/h]**. For example, to start Server Manager and administer the domain Shipping using Low Speed Connection, you would type **srvmgr shipping /l**.

## Managing Server Properties

### To manage properties

1. In the Server Manager window, double-click a computer name.

The Properties dialog box appears, displaying a summary of connections and resource usage.

2. To change the computer description, type new text in the Description box.
3. To administer a property associated with one of the buttons at the bottom of the Properties dialog box, choose a button and complete the dialog box for that property.

There are five buttons: [Users](#), [Shares](#), [In Use](#), [Replication](#), and [Alerts](#).

4. When you finish managing properties, choose the OK button in the Properties dialog box.

## Viewing User Sessions

### To view a list of users connected to the computer

1. In the Server Manager window, double-click a computer name.
2. In the Properties dialog box, choose the Users button.

The User Sessions dialog box appears. The Connected Users box lists the users who are connected over the network to the computer.

3. To view the resources opened by one user, select a user name from the Connected Users box.

The Resource box lists the shared resources that user is connected to.

4. Optionally, to disconnect one user, select the user name from the Connected Users box and then choose the Disconnect button. To disconnect all users, choose the Disconnect All button. Warn connected users before disconnecting them.

Note: While you are remotely administering another computer, your user account will be listed as a user connected to the IPC\$ resource. It cannot be disconnected.

5. To exit choose the Close button, and then in the Properties dialog box choose the OK button.

## Viewing Shared Resources

Use the Shared Resources dialog box to view the shared resources available on the computer, and the users connected over the network to a selected shared resource.

Note: To share directories or manage shared directories, use the Shared Directories command from Server Manager, or use File Manager. To share printers or manage shared printers, use Print Manager.

### To view a list of the computer's shared resources

1. In the Server Manager window, double-click a computer name.
2. In the Properties dialog box, choose the Shares button.

The Shared Resources dialog box appears. The Sharename box lists the shared resources available on the computer.

3. To view the users connected to a shared resource, select a share name from the Share Name box.

The Connected Users box lists the connected users.

4. Optionally, to disconnect one user from all shared resources, select the user name from the Connected Users box and then choose the Disconnect button. To disconnect all users from all shared resources, choose the Disconnect All button.

Warn connected users before disconnecting them. Each disconnected user is disconnected from all shared resources on the computer (not just the resource selected in the Sharename box).

Note: While you are remotely administering another computer, your user account will be listed as a connected user for the IPC\$ share. It cannot be disconnected.

5. To exit choose the Close button, and then in the Properties dialog box choose the OK button.

5. To exit choose the Close button, and then in the Properties dialog box choose the OK button.

## Managing Export Replication

Only Windows NT Advanced Servers can be set up as replication export servers; Windows NT workstations cannot.

Make sure an appropriate logon account has been assigned to the [Directory Replicator](#) service before performing the following procedure.

### To set up an export server

1. Use File Manager to create the subdirectories that will be exported. These must be subdirectories of the replication [From Path](#).

Optionally, to these subdirectories add the files that will be exported. However, it is not necessary to add files at this time. Once you set up replication, any files later added to these subdirectories will be exported automatically. You can also later add additional subdirectories to the replication From Path.

2. In the Server Manager window, double-click the computer name of the replication export server.
3. In the Properties dialog box, choose the Replication button.
4. In the Directory Replication dialog box, select the Export Directories option.
5. Optionally, to change the path from which subdirectories will be exported, type a local path in the [From Path](#) box.
6. To export subdirectories to a domain or computer, under Export Directories choose the Add button, and then complete the Select Domain dialog box that appears. The domain name or computer name is added to the To List.

Note: By default, the To List contains a blank entry and this computer automatically exports to the local domain. If any entries are added to the To List, the local domain is no longer exported to. If necessary, the domain name must be explicitly added to the To List.

7. To stop exporting subdirectories to a domain or computer, under Export Directories, select the domain or computer from the To List, and then choose the Remove button.
8. To manage locks, stabilization, and subtree replication for the subdirectories exported from this computer, under Export Directories choose the Manage button, and then complete the dialog box that appears.
9. To exit, choose the OK button in the Directory Replication dialog box.

If it does not already exist, the system creates the special REPL\$ share, required for export replication. If it is not already running, the system starts the Directory Replicator service.

10. In the Properties dialog box, choose the OK button.

## **Directory Replication**

Directory replication is the duplication of a master set of directories from a server (called an export server) to specified servers or workstations (called import computers) in the same or other domains. A Windows NT Advanced Server can be an export server, an import computer, or both. A Windows NT workstation can only be an import computer.

Replication simplifies the task of maintaining identical sets of directories and files on multiple computers, because only a single master copy of the data must be maintained. Once replication is set up, replication occurs each time a change is made to one of the files in a directory set for export.

## **Directory Replicator service**

Before replication can occur, an appropriate logon account must be assigned to the Directory Replicator service of each computer that will participate in replication.

Use User Manager for Domains to create a domain user account that the Directory Replicator service will use to log on. This account must have the Password Never Expires option selected, all logon hours allowed, and membership in the domain's Backup Operators group.

For each computer that will participate in replication, use Server Manager to configure the Directory Replicator service to start up automatically, and to log on using the user account described above.

## Managing Import Replication

Both Windows NT Advanced Servers and Windows NT workstations can be set up as replication import computers.

Make sure an appropriate logon account has been assigned to the [Directory Replicator](#) service before performing the following procedure.

### To set up an import computer

1. In the Server Manager window, double-click the appropriate computer name.
2. In the Properties dialog box, choose the Replication button.
3. In the Directory Replication dialog box, select Import Directories.
4. Optionally, to change the path in which imported subdirectories will be stored, type a local path in the [To Path](#) box.
5. To import subdirectories from a domain or export server, under Import Directories choose the Add button, and then complete the Select Domain dialog box that appears. The domain name or computer name is added to the From List.

Note: By default, the From List contains a blank entry and this computer automatically imports from the local domain. If any entries are added to the From List, the local domain is no longer imported from. If necessary, the domain name must be explicitly added to the From List.

6. To stop importing subdirectories from an export server or domain, select the domain name or computer name in the From List, and then choose the Remove button.
7. To view a list of the subdirectories that have been imported to this computer, or to manage locks on those imported subdirectories, under Import Directories choose the Manage button, and then complete the dialog box that appears.
8. To exit, choose the OK button in the Directory Replication dialog box.

If it is not already running, the system starts the Directory Replicator service.

9. In the Properties dialog box, choose the OK button.

## Setting the Logon Script Path

A *logon script* is an optional file that runs each time a user logs on. It can be a batch file (.BAT or .CMD filename extension) or an executable program (.EXE filename extension). A *logon script path* is a local path to the directory where logon scripts are stored.

When a server authenticates a logon request and that user account has a logon script assigned, the system locates the logon script by combining a local logon script path specified in Server Manager with a filename (and optionally a relative path) specified in User Manager.

For a domain, master copies of every logon script should be stored under one replication export directory of one Windows NT Advanced Server. Copies of these master logon scripts should be replicated to the other servers of the domain. Then, for each Windows NT Advanced Server, the path to imported logon scripts must be entered in the Logon Script Path box of the Directory Replication dialog box.

For Windows NT workstations, the logon script path cannot be changed from the default (usually, C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS).

### To configure the logon script path for a server

1. In the Server Manager window, double-click the computer name of the server.
2. In the Properties dialog box, choose the Replication button.
3. In the Logon Script Path box, type a local path.

Usually, you will enter a path to a \SCRIPTS subdirectory of the replication To Path. For example, C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS.

An entry is required. Do not enter a blank in the Logon Script Path box.

4. To exit choose the OK button, and then in the Properties dialog box choose the OK button.

## **Managing Administrative Alerts**

You can determine which users and computers are notified when administrative alerts occur at a selected computer. Administrative alerts are generated by the system, and relate to server and resource use. They warn about security and access problems, user session problems, server shutdown because of power loss when the UPS service is available, and printer problems.

### **To manage the recipients of administrative alerts**

1. In the Server Manager window, double-click a computer name.
2. In the Properties dialog box, choose the Alerts button.
3. To add a user or computer to the list of alert recipients, type the user name or computer name in the New Computer Or User name box, and then choose the Add button.
4. To remove a user or computer from the list of alert recipients, select the user name or computer name from the Send Administrative Alerts To box, and then choose the Remove button.
5. To exit, in the Alerts dialog box choose the OK button, and then in the Properties dialog box choose the OK button.

## **Viewing Shared Directories**

### **To view the shared directories of a computer**

1. Select a computer from the list in the Server Manager window.
2. From the Computer menu, choose Shared Directories.

The Shared Directory dialog box lists the shared directories of the computer, and shows the path of each shared directory.

3. To exit, choose the Close button.

## Sharing a Directory

## Setting Permissions for a Shared Directory

Share permissions determine which users are allowed to access a shared directory, and the type of access those users are allowed. These permissions control network access to the shared directory, its subdirectories, and their files. Share permissions are effective only when the shared directory is accessed over the network.

Permissions set on a share that is on an NTFS volume operate in addition to NTFS permissions set on the directory itself. On NTFS volumes, share permissions specify the maximum access possible, while directory and file permissions specify the maximum access allowed. For NTFS volumes it is usually better to restrict access by managing the permissions set on directories and files, rather than the permissions set on shares.

### To set permissions for a shared directory

1. Select a computer from the list in the Server Manager window, and then from the Computer menu choose Shared Directories.
2. In the Shared Directories dialog box choose the New Share button, or select a share name from the list and then choose the Properties button.
3. Choose the Permissions button.
4. To change a permission, select a group or user account from the Name list, and then select a permission from the list in the Type Of Access box.
5. To add a group or user account to the list of those granted permissions for this shared directory, choose the Add button and complete the Add Users And Groups dialog box that appears.

When assigning permissions it is usually better to assign permissions to groups, rather than to individual user accounts.

6. To remove a group or user account from the list of those granted permissions for this shared directory, select a group or user account from the Name list, and then choose the Remove button.
7. To exit, choose the OK button from the Access Through Share Permissions dialog box, choose the OK button again from the New Share or Share Properties dialog box, and then from the Shared Directories dialog box choose the Close button.

## Stopping Directory Sharing

### To stop sharing a directory

1. Select a computer from the list in the Server Manager window, and then from the Computer menu choose Shared Directories.
2. In the Shared Directories dialog box, select a share name from the list.

In most cases you should not select one of the special shares which, if it appears in the list, was created by the system (for example, A\$, B\$, C\$, ADMIN\$, IPC\$, NETLOGON, PRINT\$ or REPL\$).

3. Choose the Stop Sharing button.

The directory itself is not removed, but it is no longer shared and can no longer be accessed by network users.

4. To exit, choose the Close button.

## Special Shares


A computer's shared resources include those resources (such as directories) that have been shared by a user or an administrator, plus any special shares that may have been created by the system.

Depending on the configuration of the computer being administered, some or all of the following special shares may appear when Windows NT presents a list of the computer's shared resources. These shares are created by the system. In most cases, these special shares should not be deleted or modified. For more information choose one of the following buttons.

***driveletter\$***

A share which allows administrative personnel to connect to the root directory of a storage device. Shown as A\$, B\$, C\$, D\$, and so on. For example, D\$ is a share name by which drive D might be accessed by an administrator over the network.

For a Windows NT workstation, only members of the Administrators and Backup Operators can connect to these shares. For a Windows NT Advanced Server, members of the Server Operators group can also connect to these shares.

## **ADMIN\$**

A resource used by the system during remote administration of a computer. The path of this resource is always the Windows NT system root (the directory in which Windows NT is installed: for example, C:\WINNT).

For a Windows NT workstation, only members of the Administrators and Backup Operators can connect to this share. For a Windows NT Advanced Server, members of the Server Operators group can also connect to this share.

**IPC\$**

A resource sharing the named pipes that are essential for communication between programs. Used during remote administration of a computer, and when viewing a computer's shared resources.

## **NETLOGON**

A resource used by the Net Logon service of a Windows NT Advanced Server while processing domain logon requests.

Note: This resource is only provided for Windows NT Advanced Servers. It is not provided for Windows NT workstations.



**PRINT\$**

A resource that supports shared printers.

**REPL\$**

A resource created by the system when a Windows NT Advanced Server is configured as a replication export server. It is required for export replication.

Note: This resource is only provided for Windows NT Advanced Servers which are configured as replication export servers. It is not provided for Windows NT workstations.

## Starting and Stopping Services

Use the Services dialog box to start, stop, pause, or continue each of the services available on the selected computer, and to pass startup parameters to the service.

Note: Because stopping the Server service disconnects all remote connected users, warn users before stopping that service. Also, once the Server service is stopped, that computer can no longer be remotely administered, and its Server service can only be restarted locally.

### To start, stop, pause, or continue a service

1. Select a computer from the list in the Server Manager window, and then from the Computer menu choose Services.
2. In the Services dialog box, select the service.
3. Choose the Start, Stop, Pause, or Continue button.

Optionally, to pass startup parameters to a service, type the parameters in the Startup Parameters box before choosing the Start button.

4. In the Services dialog box, choose the Close button.

## Configuring Service Startup

To configure service startup, you must be logged on to a user account that has membership in the Administrators local group.

### To configure startup for a service

1. Select a computer from the list in the Server Manager window, and then from the Computer menu choose Services.
2. In the Services dialog box, select the service.
3. Choose the Startup button.
4. In the Service Startup dialog box, select a startup type of Automatic, Manual, or Disabled.
5. To specify the user account the service will use to log on, select System Account or This Account.
6. If you select This Account, also choose the Browse button  and specify a user account by completing the Add User dialog box that appears.  
After closing the Add User dialog box, type the password for the user account in both the Password and Confirm Password boxes.
7. Choose the OK button, and then in the Services dialog box choose the Close button.

## Assigning a Logon Account to the Directory Replicator Service

Most aspects of [directory replication](#) are managed for a particular computer by using either the Server Manager Properties command or the Server option in Control Panel.

However, before a computer can participate in replication, you must create a special user account and then, for each computer in a domain that will participate in replication, configure its Directory Replicator service to log on using that special account.

### To assign a logon account to the Directory Replicator service

1. Use User Manager for Domains to create a domain user account, configuring the account so that:
  - ▣ The Password Never Expires option is selected.
  - ▣ All logon hours are allowed.
  - ▣ The user account has membership in the domain's Backup Operators group.
2. For each computer that will participate in replication, use Server Manager or the Services option in Control Panel to configure the computer's Directory Replicator service to start up automatically, and to log on using the user account you created in step 1.

## **Assigning a Logon Account to the Schedule Service**

The Schedule service must be running if the AT command is to be used. The AT command can schedule commands and programs to run on a computer at a specified time and date.

By default, the Schedule service is configured to log on under the system account; the same account that is used by most services. However, when the Schedule service logs on under the system account, the AT command can only be used to access those network resources that permit Guest access.

In many cases, if you want the AT command to access network resources, you must create a special user account and then configure the Schedule service to log on using that user account.

### **To assign a logon account to the Schedule service**

1. Create a user account for the service using User Manager or User Manager for Domains. When creating the account, select the Password Never Expires option.
2. Give the account membership in the appropriate groups. The particular group memberships you assign will depend on the operations that must be accomplished remotely.

For example, if the AT command is to be used to perform regularly scheduled backups of the hard disk of a remote server in a Windows NT Advanced Server domain, the user account created for the Schedule service must be a member of the domain's Backup Operators local group.

3. Assign the user account to the Schedule service using Server Manager or the Services option in Control Panel.

**Alerter service**

Notifies selected users and computers of administrative alerts that occur on the selected computer. Used by the Server and other services. Requires the Messenger service.



**Clipbook Server service**

The Clipbook Server service supports the Clipbook Viewer application, allowing pages to be seen by remote Clipbooks.

**Computer Browser service**

Maintains an up-to-date list of computers, and provides the list to applications when requested. Provides the computer lists displayed in the Select Computer and Select Domain dialog boxes; and in the main Server Manager window.

**Directory Replicator service**

Replicates directories, and the files in those directories, between computers.

**Event Log service**

Records system, security, and application events in the event logs.

**Messenger service**

Sends and receives messages sent by administrators or by the Alerter service.

**Net Logon service**

For Windows NT Advanced Server, performs authentication of account logons, and also keeps the domain's security database synchronized between the domain controller and the other Windows NT Advanced Servers of the domain.

For Windows NT workstations, supports pass through authentication of account logons. Used when the workstation participates in a domain.

**Network DDE service**

The Network DDE (Dynamic Data Exchange) service provides a network transport as well as security for DDE conversations.

**Network DDE DSDM service**

The Network DDE DSDM (DDE Share Database Manager) service manages the shared DDE conversations. It is used by the Network DDE service.



## **Remote Procedure Call (RPC) Locator service**

The Remote Procedure Call (RPC) Locator service allows distributed applications to use the Microsoft RPC name service. The RPC Locator service manages the RPC name service database.

The server side of a distributed application registers its availability with the RPC Locator service. The client side of a distributed application queries the RPC Locator service to find available compatible server applications.

## **Remote Procedure Call (RPC) service**

The Remote Procedure Call (RPC) Service is the RPC subsystem for Microsoft Windows NT. The RPC subsystem includes the endpoint mapper and other miscellaneous RPC services.

**Schedule service**

The Schedule service must be running if the AT command is to be used. The AT command can be used to schedule commands and programs to run on a computer at a specified time and date.

**Server service**

Provides remote procedure call (RPC) support, and file, print, and named pipe sharing.

**UPS service**

Manages an uninterruptible power supply connected to this computer.

**Workstation service**

Provides network connections and communications.

## **Sending a Message to Connected Users**

Use the Send Message command to send a message to all users who are connected to a computer. You may want to do this before you administer the computer with Server Manager, particularly if you will be disconnecting one or more users, or if you will be stopping the Server service on that computer.

### **To send a message to connected users**

1. Select a computer from the list in the Server Manager Window.
2. From the Computer menu, choose Send Message.
3. Type your message in the Message box.
4. Choose the OK button.

## **Promoting a Server to Domain Controller**

### **To promote a server to domain controller**

1. Select a server from the list of computers in the Server Manager window. Choose a computer that is capable of reliably handling high network traffic loads.
2. From the Computer menu, choose Promote To Domain Controller.  
If it is available, the former domain controller is demoted to server status.



## **Demoting a Domain Controller to Server**

Usually, when a server is promoted to domain controller, no special action needs to be taken to demote the former domain controller to server status, because the system does this automatically.

However, if a server is promoted to domain controller while the existing domain controller is unavailable (for example, if it is being repaired), and if the former domain controller later returns to service, you must demote it.

### **To demote a Domain Controller to Server**

1. Select the former domain controller from the list of computers in the Server Manager window.

On the Computer menu, the Promote To Domain Controller command changes, becoming the Demote To Server command.

2. From the Computer menu, choose Demote to Server.

## **Synchronizing a Server with the Domain Controller**

Synchronization is usually done automatically by the system, but if the security database on a Windows NT Advanced Server becomes unsynchronized, or if a LAN Manager 2.x server is unable to establish network connections, there is a manual way to correct the situation. It is rarely necessary.

### **To synchronize a server with the domain controller**

1. Select the server from the list in the Server Manager window.
2. From the Computer menu, choose Synchronize with Domain Controller.

## **Synchronizing All Servers of the Domain**

Synchronizing is usually done automatically by the system, but if the security database becomes unsynchronized between the domain controller and the other domain servers, there is a manual way to correct the situation. It is rarely necessary. It can take a substantial amount of time to complete.

### **To synchronize all the servers of the domain**

1. Select the domain controller from the list in the Server Manager window.
2. From the Computer menu, choose Synchronize Entire Domain.

The domain's security database is replicated from the domain controller to all the servers of the domain.

## Adding a Computer to the Domain

To add a computer to a domain, you must be logged on to a user account that is a member of the Administrators, Domain Admins, or Account Operators group of that domain.

### To add a computer to a domain

1. From the Computer menu, choose Add To Domain.
2. In the Add Computer to Domain dialog box, select either the Windows NT Workstation option or the Windows NT Advanced Server option.
3. Type the computer name in the Computer Name box.
4. Choose the Add button.

In the domain's security database, an account is added for that computer name.

5. Choose the Close button.

The computer is added to Server Manager's list. However, until the computer joins the domain (as described in step 6), in Server Manager's list the computer's icon is dimmed and its version number and description are absent.

6. After a computer has been added, instruct the user of that computer to join the domain.

For Windows NT workstations this can be done either while installing Windows NT on the computer, or after installation using the Network option of that computer's Control Panel. For Windows NT Advanced Servers, this can only be done during installation.

Note: Treat an added computer name as a security element. Until the intended computer joins the domain, it is possible for a user to give a different computer that computer name, and then have it join the domain using the computer account you have just created. If the added computer is a server, when it joins it receives a copy of the domain's security database.

## **Removing a Computer from the Domain**

After a computer is removed from a domain, it can no longer participate in domain security. The computer's account is deleted from the domain's security database.

### **To remove a computer from the domain**

1. Select a computer from the list in the Server Manager window.  
Do not select the domain controller. It cannot be removed.
2. From the Computer menu, choose Remove From Domain.
3. Instruct the user of that computer to remove this domain name from the Network option in Control Panel, and to enter (as appropriate) another domain name or workgroup name.

## Changing a Computer Name

### To change a computer name

1. From the Computer menu, choose Add To Domain and complete the Add Computer To Domain dialog box, specifying the new computer name.
2. Instruct the user of that computer to change the computer name in the Network option in Control Panel.
3. Select the old computer name from the list in the Server Manager window, and then from the Computer menu, choose Remove From Domain.

**Service**

One service at a time can be selected. Once selected, a service can be stopped, started, paused, continued, or configured for startup.



## Status

The status of a service can be:

- ▣ Started
- ▣ Paused
- ▣ Stopped (represented by a blank entry)

## Startup

The startup type of a service can be

- ▣ Automatic (service starts every time the system starts)
- ▣ Manual (service can be started by a user or a dependent service)
- ▣ Disabled (service cannot be started)

**Start button**

► To start a service that is stopped, select the service, and then choose the Start button.

Optionally, to pass startup parameters to the service, type text in the Startup Parameters box before choosing the Start button.

## **Stop button**

▣ To stop a service that is running, select the service, and then choose the Stop button. If another service is dependent on the service you stop, you will be warned before the action completes.

Note: Because stopping the Server service disconnects all remote connected users, warn users before stopping that service. Also, once the Server service is stopped, that computer can no longer be remotely administered, and its Server service can only be restarted locally.

### **Pause button**

▣ To pause a service that is running, select the service, and then choose the Pause button.

### **Continue button**

➤ To return to normal operation a service that has been paused, select the service, and then choose the Continue button.

## **Startup button**

To configure service startup you must be logged on to a user account that has membership in the Administrators local group.

- To specify the startup type of a service or to assign a logon account to a service, select the service, choose the Startup button, and complete the dialog box that appears.

## **Startup Parameters**

- ▣ To pass startup parameters to a service, select the service, type the parameters in the Startup Parameters box, and then choose the Start button.

## **Startup Type**

- ▣ To specify the startup behavior of the service, choose Automatic, Manual, or Disabled.

**Automatic**

Automatic services start every time the system starts.

Note: The Server service will not start automatically unless the computer has at least 12MB of random-access memory.

**Manual**

Manual services can be started by a user or by a dependent service.

**Disabled**

Disabled services cannot be started by users, nor by dependent services.

## **Log On As**

When services start, they log on.

Most services must log on to the system account. Usually, of the default services provided with Windows NT only the Directory Replicator and Schedule services log on using other user accounts.

## **System Account**

When services start, they log on. Most services must log on using the system account.

## **This Account**

Select this option to assign a logon user account to a service.

When services start, they log on. Although most services must log on to the system account, some services can be configured to log on to special user accounts. (Usually, of the default services provided with Windows NT, only the Directory Replicator and Schedule services will be configured in this manner.)

A user account used to log on a service should be created in User Manager specifically for that purpose. Make certain that the user account has the Password Never Expires option selected, and has membership in the appropriate groups. The particular group memberships assigned will depend on the operations that must be accomplished by the service.



## **Browse button**

- To specify the user account the service will log on to, select This Account, choose the Browse button, and then complete the Add User dialog box that appears.

### **Password and Confirm Password**

■ In the Password box, type the password for the user account entered in This Account box. Type the same password in the Confirm Password box.

This is the password that was assigned to the user account in User Manager.  
Remember, passwords are case sensitive.

## **Stopping Dependent Services**

Windows NT Advanced Servers can export and import. Windows NT workstations can only import.

- ☐ Choose the Replication button to manage directory replication for the computer. For a server, also choose the Replication button to specify the path to user logon scripts.

## **Alerts button**

Administrative alerts are generated by the system and relate to server and resource use. They warn about security and access problems, user session problems, server shutdown because of power loss when the UPS service is available, and printer problems. For example, an alert is generated when disk space becomes low. You can determine which users and computers are notified when administrative alerts occur at the computer.

## **Password**

You must provide a valid password to administer a LAN Manager 2.x server that is using share-level security.

## Alerts

## Add Computer to Domain

Before a Windows NT workstation or a Windows NT Advanced Server can be a domain member and participate in domain security, it must be added to the domain. Computers that are added to a domain are given accounts in the domain's security database. There are three ways to add computers to a domain, but only one of them requires Server Manager. That method uses the Add Computer To Domain dialog box.

- A workstation can be added to a domain during installation of Windows NT, and a server can be added to a domain during installation of Windows NT Advanced Server, but only when the installations are performed by an Administrator.

- An Administrator can add an existing Windows NT workstation to a domain using the Network option of that workstation's Control Panel.

- Or, an Administrator or an Account Operator can use Server Manager's Add Computer To Domain dialog box to add a computer account to the domain's security database. Then the computer's user must have the computer join the domain under that computer account. This can be accomplished by a user as part of workstation or server installation; or, for a workstation, after installation by using the Network option in Control Panel.

Note: Treat the added computer name as a security element. Until the intended computer joins the domain, it is possible for a user to give a different computer that computer name, and then have it join the domain using the computer account you have just created. If the added computer is a server, when it joins it receives a copy of the domain's security database.

## **Domain**

☐ To display a domain, type the *domainname* in the Domain box and then choose the OK button.

To display a Windows NT workgroup, type the *workgroupname* in the Domain box and then choose the OK button.

To display only one computer, type the *\\computername* (precede computer names with two backslashes) and then choose the OK button.

### **Select Domain**

☐ To display one of the listed domains, select that domain name from the Select Domain list and then choose the OK button.

## **Low Speed Connection**

When selecting a domain, workgroup, or computer that communicates with your computer across a connection providing relatively low transmission rates, select the Low Speed Connection option. This option prevents automatic refreshes of the Server Manager screen, which may be time consuming when performed across low speed connections. (These refreshes occur automatically after some Server Manager functions, such as changing computer properties, managing services, or promoting a server to domain controller.) When the Low Speed Connection option is selected, the Server Manager screen can still be refreshed manually by choosing the Refresh command from the View menu.

For example, from a Windows NT Advanced Server you might administer a remote Windows NT workstation that is running the Microsoft Windows NT Remote Access Service and is connected to the network by a modem over telephone lines. When entering the computer name in Server Manager's Select Domain dialog box, you should select the Low Speed Connection option.

Low Speed Connection can also be selected (or cleared) by choosing the Low Speed Connection command from the Options menu.



## **Add User**

Use the Add User dialog box to select the user account the service will use to log on.

This should be a user account created in User Manager specifically for logging on the service. Make certain that the user account has the Password Never Expires option selected, and has membership in the appropriate groups. The particular group memberships assigned will depend on the operations that must be accomplished by the service. Usually, of the default services provided with Windows NT, only the Directory Replicator and Schedule services have a user account assigned in this manner.

## **List Names From**

The List Names From box shows the domain or computer from which the user account can be selected. The groups of that domain or computer are listed in the Names box.

☐ To change the selected domain or computer, select a domain name or computer name from the list in the List Names From box.

**Names**

Lists the user accounts of the domain or computer selected in the List Names From box.

**Add button**

After a name is selected from the Names list, choosing Add places that name in the Add Name list.

### **Search button**

☐ To search for a particular user account, choose the Search button and complete the dialog box that appears.

## **Add Name**

A user account can be added to this box by typing its name in the box; by selecting it from the Names box and choosing the Add button; or by choosing the Search button and completing the dialog box that appears.

☐ To have the service log on using the account displayed in the Add Name list, choose the OK button.

## **Local Group Membership**

The Local Group Membership dialog box lists the user accounts and global groups that are members of the selected local group.

### **Members Of**

☐ To add user accounts or global groups to the Add Names list in the Add User dialog box, here in the Local Group Membership dialog box select one or more names from the Members Of list, and then choose the OK button.

### **Members Button**

☐ To list the members of a global group (that is itself a member of this local group), select the global group from the Members Of list, and then choose the Members button.

## **Global Group Membership**

The Global Group Membership dialog box lists the user accounts that are members of the selected global group.

### **Members Of**

☐ To add user accounts to the Add Names list in the Add User dialog box, here in the Global Group Membership dialog box select one or more names from the Members Of list, and then choose the OK button.



## **Verify Synchronization**

Synchronize with Domain Controller reestablishes the computer's account password on both that computer and the domain controller. This is usually done automatically by the system, but if the computer becomes unsynchronized and is unable to establish network connections, this is a manual way to correct the situation. It is rarely necessary.

## **Verify Domain Synchronization**

Synchronize Entire Domain replicates the domain's security database from the domain controller to all the servers in the domain. This is usually done automatically by the system, but if the databases become unsynchronized, this is a manual way to correct the situation. It is rarely necessary. It can take a substantial amount of time to complete.

## **Cannot Find Domain Controller**

The domain controller for the specified domain could not be found. You may have entered an incorrect domain name, the domain controller may be currently unavailable to the network, or the specified domain may not exist.

## **Warning, No Domain Controller**

The domain controller for this domain cannot be found. Usually, during a promotion the domain security database of the old domain controller is replicated to the new domain controller. Then the old domain controller is demoted to server status. This ensures that the new domain controller receives the domain's latest security database.

If you proceed with the promotion at this time, this server's existing copy of the domain security database will be used. It may or may not be up-to-date. If you expect the domain controller to be available soon, it is a good idea to wait and to promote this server at that time.

## **Verify Role Change**

During a promotion, the domain security database from the old domain controller is replicated to the new domain controller. Then the old domain controller is demoted to server status. This operation can take several minutes.

## **Close Resources**

Closing resources can result in loss of data. It is a good idea to send a warning to connected users before closing resources.

**Do Not Export**

Prevents replication from this computer. Subdirectories are not exported.

**Export Directories**

Enables replication from this computer. Subdirectories of the From Path are exported.

**Manage button (under Export Directories)**

Displays the Manage Exported Directories dialog box, where export locks can be added or removed, and export stabilization and subtree export can be enabled or disabled.

**From Path**

A local path to a directory from which subdirectories and files are exported.

The default From Path is C:\WINNT\SYSTEM32\REPL\EXPORT. If Windows NT is installed in a location other than C:\WINNT, the system adjusts the default accordingly. Usually, you will not need to change the default From Path.

## **To List**

Subdirectories are exported from this export server to the domains and computers of the To List.

By default, the To List contains a blank entry and this computer automatically exports to the local domain. If any entries are added to the To List, the local domain is no longer exported to. If necessary, the domain name must be explicitly added to the To List.

Replication to a domain name does not always succeed when some or all import computers of that domain are located across a wide area network (WAN) bridge from this export server. In this situation, you must explicitly add the computer names of those import computers to the To List.

**Do Not Import**

Prevents replication to this computer. Subdirectories are not imported.

**Import Directories**

Allows replication to this computer. Subdirectories are imported.



**Manage button (under Import Directories)**

Displays the Manage Imported Directories dialog box, where import locks can be added or removed.

**To Path**

A local path to a directory in which imported subdirectories and files are stored.

The default To Path is C:\WINNT\SYSTEM32\REPL\IMPORT. If Windows NT is installed in a location other than C:\WINNT, the system adjusts the default accordingly. Usually, you will not need to change the default To Path.

## **From List**

Subdirectories are replicated to this import computer from the domains and computers of the From List.

By default, the From List contains a blank entry and this computer automatically imports from the local domain. If any entries are added to the From List, the local domain is no longer imported from. If necessary, the domain name must be explicitly added to the From List.

Replication from a domain name does not always succeed when export servers of that domain are located across a wide area network (WAN) bridge from this import computer. In this situation, you must explicitly add the computer names of those export servers to the From List.

**Add button**

Displays the Select Domain dialog box.

The Add button under Export Directories is used to add a computer name or domain name to the To List.

The Add button under Import Directories is used to add a computer name or domain name to the From List.

**Remove button**

Removes a selected computer name or domain name from the list.

The Remove button under Export Directories is used to remove a computer name or domain name from the To List.

The Remove button under Import Directories is used to remove a computer name or domain name from the From List.

## **Logon Script Path**

A local path to a directory where logon scripts are stored. When a server authenticates a logon request and that user account has a logon script assigned, the system locates the logon script by combining the local path specified here, with a filename (and optionally a relative path) specified in User Manager.

For a domain, master copies of every logon script should be stored under one replication export directory of a Windows NT Advanced Server. Copies of these logon scripts should be replicated to the other servers of the domain. Then, for each Windows NT Advanced Server, the local path to imported logon scripts should be entered here, in the Logon Script Path box.

Usually, you will enter a path to a \SCRIPTS subdirectory of the replication To Path. For example, C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS.

An entry is required. Do not enter a blank in the Logon Script Path box.

**Export Path**

The path to the directory from which subdirectories and files are exported.

**Subdirectory**

A list of the subdirectories that are exported from this computer.

When a subdirectory is created in the export path (using File Manager or the command prompt), it is automatically added to this list.

**Locks**

The number of locks applied to the subdirectory.

A lock prevents subdirectory export, and more than one lock might be applied to a subdirectory. Export occurs only if this column has a value of zero.

**Stabilize**

Yes indicates that all files and subdirectories in that subdirectory tree must be stable (cannot be changed) for two minutes (or more) before replication can occur. No indicates that each file can be replicated as soon as it is changed.

The default is No. To change this setting, use the Wait Until Stabilize check box.

**Subtree**

Yes indicates that the entire subdirectory tree will be exported. No indicates that only the first-level subdirectory will be exported.

The default is Yes. To change this setting, use the Entire Subtree check box.

**Locked Since**

The date and time that the oldest lock was placed on this subdirectory.



**Export Settings For**

Shows the name of the selected subdirectory.

**Add Lock button**

Adds a lock to the selected subdirectory, preventing export.

**Remove Lock button**

Removes a lock from the selected subdirectory. Export only occurs when a subdirectory has zero locks.

**Wait Until Stabilized**

If selected, no changes can occur for two minutes (or more) to any subdirectory or file in the selected subdirectory tree before replication can occur. Helps to eliminate partial replication. If cleared, each file can be replicated as soon as it is changed.

This setting is reflected in the Stabilize column.

**Entire Subtree**

If selected, the first-level export subdirectory and its files will be exported, along with all its subdirectories and their files. If cleared, only the first-level export subdirectory and its files will be exported.

This setting is reflected in the Subtree column.

**Add button**

Displays the Add Subdirectory dialog box, used to add new subdirectories to the list of exported subdirectories.

However, this is usually unnecessary because it only adds an entry to the list, and does not actually create the subdirectory. When a subdirectory is created in the export path (using File Manager or the command prompt), it is automatically added to the list.

**Remove button**

Removes the selected subdirectory from the list of exported subdirectories.

However, this is usually unnecessary because it only removes the entry in the list, not the actual subdirectory. If that subdirectory still exists in the export path, it will still be exported and will later reappear in this list.

## Manage Imported Directories

Use the Manage Imported Directories dialog box to add or remove import locks. For more information, choose one of the following buttons.

**Import Path**

The path to the directory in which replicated subdirectories and files are stored.

**Subdirectory**

A list of the replicated subdirectories that are imported to this computer.

A subdirectory is automatically imported if it is exported by one of the export servers or domains in the From List of the Directory Replication dialog box. If it is imported, it is automatically added to this list.

**Locks**

A lock prevents import to the subdirectory. More than one lock might be applied to a subdirectory. Import to a subdirectory only occurs if this column has a value of zero.

## Status

- ☐ "OK" indicates that the subdirectory is receiving regular updates from an export server and the imported data is identical to that exported.
- ☐ "No Master" indicates that the subdirectory is not receiving updates. The export server might not be running, or the export server might have stopped exporting updates.
- ☐ "No Sync" indicates that the subdirectory has received updates, but the data is not up to date. This could be due to a communications failure, open files on the import computer or export server, the import computer not having access permissions at the export server, or an export server malfunction.
- ☐ A blank entry indicates that replication has never occurred for that subdirectory. Replication may not be properly configured for this import computer, for the export server, or both.

**Last Update**

The date and time that the last update was made to a file in this import subdirectory, or in its subtree.

**Locked Since**

The date and time that the oldest lock was placed on this subdirectory.

**Import Settings For**

Shows the name of the selected subdirectory.

**Add Lock button**

Adds a lock to the selected subdirectory, preventing import.



**Remove Lock button**

Removes a lock from the selected subdirectory. Import only occurs when a subdirectory has zero locks.

**Add button**

Displays the Add Subdirectory dialog box, used to add new subdirectories to the list of imported subdirectories.

However, this is usually unnecessary because this only adds an entry to the list, and does not create the actual subdirectory. When a subdirectory is exported by one of the export servers or domains in the From List of the Directory Replication dialog box, it is automatically imported and added to this list.

**Remove button**

Removes the selected subdirectory from the list.

However, this is usually unnecessary, because this only removes the entry from the list, and does not remove the actual subdirectory. If that subdirectory is exported by one of the export servers or domains in the From List of the Directory Replication dialog box, it will still be imported and will later reappear in this list.

## **Add Subdirectory**


Use the Add Subdirectory dialog box to add a subdirectory to the Subdirectory list.

However, this is usually unnecessary, since this action only adds an entry to the list and does not create the actual subdirectory. Instead, use File Manager or the command prompt to create export subdirectories on export servers. On import computers, imported subdirectories are automatically created the first time they are received from an exporting server.

### **Path**

This is either the import path or the export path.

### **Subdirectory Name**

 To add a subdirectory to the list, type its name in the Subdirectory Name box, and then choose the OK button.

## **Select Domain**

Use the Select Domain dialog box to select a domain or a computer to be added to the replication From List or the replication To List.

Replicating to or from a domain name is a convenient way to set up directory replication between many computers, because each export server and import computer can specify only a few domain names for export or import, rather than a long list of many computer names.

### **Domain**

This box displays the current domain. You can type a *domainname* or a `\\computername` here.

### **Select Domain**

This box lists the available domains. If you double-click on a domain name, the computers in that domain are listed. You can select one of the listed domains or computers.

## Shared Directories

A shared directory can be accessed by network users. Use the Shared Directories dialog box command to share, stop sharing, modify properties of, and manage permissions for shared directories. For more information, choose one of the following buttons.

### **Shared Directories On**

The list consists of those resources that have been shared by a user or an administrator, plus any special shares that may have been created by the system (for example, A\$, B\$, C\$, ADMIN\$, IPC\$, NETLOGON, PRINT\$ or REPL\$).

### **New Share button**

☐ To share a directory, select the New Share button and complete the New Share dialog box that appears.



### **Properties button**

▣ To view or manage the properties of a shared directory, select the shared directory from the Share Directories On list, choose the Properties button, and then complete the Share Properties dialog box that appears.

### **Stop Sharing button**

▣ To stop sharing a directory, select the shared directory from the Share Directories On list, and then choose the Stop Sharing button.

The directory itself is not removed, but it is no longer shared and can no longer be accessed by network users.

**Path**

The path of a local directory to be shared. For example, you might type **c:\sales\budgets**.

**Comment**

Any text describing the shared directory. Users see this comment when connecting to the shared directory using File Manager.

This is an optional entry.

**User Limit**

Defines the maximum number of users who can connect to the shared directory at one time.

**Unlimited**

Any number of users can connect to the shared directory.



**Allow**

Only the number of users specified in the Users box can connect at one time to the shared directory.

**Users**

The maximum number of network users who can connect at one time to the shared directory.

## **Permissions button**

Permissions determine which users are allowed to access the shared directory, and the type of access those users are allowed. The default is to grant Full Control to Everyone.

■ To manage permissions for the shared directory, choose Permissions and complete the Access Through Share Permissions dialog box that appears.

## Share Properties

**Share Name**

## Access Through Share Permissions

Share permissions determine which users are allowed to access a shared directory, and the type of access those users are allowed. These permissions control network access to the shared directory, its subdirectories, and their files. Share permissions are effective only when the shared directory is accessed over the network.

Permissions set on a share that is on an NTFS volume operate in addition to NTFS permissions set on the directory itself. On NTFS volumes, share permissions specify the maximum access possible, while directory and file permissions specify the maximum access allowed. For NTFS volumes it is usually better to restrict access by managing the permissions set on directories and files, rather than the permissions set on shares.

Use the Access through Share Permissions dialog box to add, remove, or change share permissions assigned to groups or user accounts. For more information, choose one of the following buttons.

## **Current Users Warning**

You should warn connected users before disconnecting them.

You have issued the Stop Sharing command against a share to which users are connected and have open files. If you choose OK and continue, the connected users may lose data.

☐ To change the selected domain or computer, select a domain name or computer name from the list in the List Names From box.

**Names**

Lists the groups of the domain or computer selected in the List Names From box. If Show Users has been selected, it also lists the user accounts.

**Add button**

After a name has been selected from the Names list, choosing Add places that name in the Add Names list.

## **Show Users button**

By default only groups of the selected domain or computer are listed in the Name box.

- ▣ To also show user accounts in the Name box, choose Show Users.

### **Members button**

☐ To list the members of a group, select the group from the Names list, and then choose the Members button.

### **Search button**

➤ To search for a particular group or user account, choose the Search button and complete the dialog box that appears.



## **Add Names**

Groups and user accounts can be added to this box by typing their names (separated by semicolons) in the box; by selecting them from the Names box and choosing the Add button; by choosing the Search button and completing the dialog box that appears; or by selecting a group from the Names box, choosing the Members button, and completing the dialog box that appears.

☐ To add the names in the Add Names list to the list of names granted permissions for the shared directory, choose the OK button.

### **Type Of Access**

The Local Group Membership dialog box lists the user accounts and global groups that are members of the selected local group.

The Global Group Membership dialog box lists the user accounts that are members of the selected global group.

☐ To add user accounts to the Add Names list in the Add Users And Groups dialog box, here in the Global Group Membership dialog box select one or more names from the Members Of list, and then choose the OK button.

## Find Account

Use the Find Account dialog box to locate a particular user account or group. For more information, choose one of the following buttons.

### **Find User Or Group**

- ▣ In this box, type the name you want to search for.  
The system will search only for user accounts or groups of that exact name.

**Search Only In**

When selected, this option causes the search to look for a matching user or group name only in the domains and computers you have selected from the list.

The list includes the local domain or computer, and all domains trusted by the local domain.



**Search button**

Begins a search based on the parameters specified in the Find User Or Group box, and by the Search All or Search Only In options.

## **Remote Administration not Supported for Shared Directories**

The shared directories of the selected computer cannot be remotely administered. This may be because the required, special IPC\$ share does not exist at that computer.

## **Invalid Share Permissions**

You must enter any combination of the letters RWCXDAP, with no duplicates.

R (read)

W (write)

C (create)

D (delete)

X (execute)

A (change attributes)

P (change permissions)

## **Invalid Share Comment**

The entered comment is not valid. Enter a new comment.

## **Invalid Share Path**

You must provide an absolute path for the directory that is to be shared. It must be a path local to computer that is being administered.

For example, you might create a share named INVOICES with a path of C:\SHIPPING\INVOICE.

## **Invalid User Limit**

The entered user limit is not valid. Enter a new user limit.

## **Invalid Path for Special Share**

ADMIN\$ or IPC\$ are special shares. Usually, they are created automatically by the system. If you create one of these shares using the New Share dialog box, complete only the Share Name box. Leave the Path and Comment boxes empty.

## **Invalid Comment for Special Share**

ADMIN\$ or IPC\$ are special shares. Usually, they are created automatically by the system. If you create one of these shares using the New Share dialog box, complete only the Share Name box. Leave the Comment and Path boxes empty.



## **New Share Password**

You are administering a shared directory of a LAN Manager 2.x server that is running share-level security, and you have specified a new password for the share. A user will need to provide the new password in order to connect to this share.

If this is what you intended, choose the OK button; if not, choose the Cancel button.

## **Shared Directory Path Change Warning**

You have entered a new path for an existing shared directory. In effect, you are stopping sharing of the existing shared directory, and are sharing another directory under the existing share name.

If this is what you intended, choose the OK button; if not, choose the Cancel button.

## **Cannot Set Permissions**

Server Manager cannot set permissions on a LAN Manager server running user-level security.

## **Password for Shared Directories Administration**

You are attempting to administer the shared directories of a LAN Manager 2.x server that is running share-level security. You must provide a password valid for the special ADMIN\$ share on that server.

## Share Permissions

Use the Share Permissions dialog box to set the access type and password for the selected share. For more information, choose one of the following buttons.

**Access Type**
