## **Section 1 ----- Getting Started**

When you first start FontMe!, a font is selected for you in both list #1 and list #2 unless there is a problem in which case you must select a font name from either list #1 or list #2. Once you have selected a font name the font will appear in the box at the bottom of the screen (Example font list #1 or 2). You can now change the size and/or style for the fonts you have selected. If for example, you select Times in list 1 and you find a font that look like Times but is slanted, select that font in list 2, then select Italic for list #1. If they both look the same you really don't need the second font (unless you really like collecting fonts). This is the whole idea behind FontMe!. You can now compare fonts easily and remove the fonts that are similar or duplications with different names. At the right hand side of the screen in the title box you will find a count of the fonts in list 1 and list 2. This count may vary if you select printer fonts from the options menu (explained below).

## **Section 2 ----- Options Menu**

*Show List #2 ----- Screen*

This is the default for the program. Both lists will have the screen fonts shown when the program first starts. These are the fonts Windows recognizes as being installed in your system and usable for display.

*Show List #2 ----- Printer*

This list is the fonts that Windows recognizes as being printable fonts. TrueType, ATM, MoreFonts and Others that install themselves or will allow you to install them in Windows are usually recognizes as both screen and printer fonts. If you are on an Apple network the printer fonts are the ones recognized by the Apple printer.

*Show List #2 ----- Saved*

This list is the fonts that you have saved from a previous visit to FontMe!. This can be useful if you are changing fonts or collecting fonts. The date the font file was saved will appear on the top of the screen. This is a standard text file and can be viewed by any text editor (select \*.\*).

*Print ----- Font #1 Only*

This will print the font which is showing in list #1. Print format example below,

*Print ----- Font #2 Only*

This will print the font which is showing in list #2. This will print in the same format as the above example. Font #1 and Font #2 Only print is printed in 14 point size only. This is a good example of the font and its characteristics including the extended characters that are printable. None printable extended characters will show either a box, space or dot.

*Print ----- Compare ----- Both as Normal*

This will print both the selected fonts from list #1 and list #2. Both are printed at normal and 14 point size only. Print format example below.

The side by side compare will show the font from list #1 on the left and the font from list #2 on the right.

*Print ----- Compare ----- Both as Shown*

This will print both the selected fonts from list #1 and list #2. Both are printed at the selected size and style from the screen selections. Note: you must make the selections before you can print this format. No extended characters will be printed in the comparison mode of printing. Print format example below.

*Print ----- Example of All fonts ----- Font as Title*

This will allow you to print all the fonts that are in List #1. You will be notified of the amount of pages that will be required to print this list. This is an approximation only. When you have selected this option, and have verified your action a scale will appear between the example font list #1 and #2. This will move across to notify you that the program is spooling. At the end of this print out (last page), you will get a page that shows you the fonts that did not print, and a printout from your win.ini font substitute list (see below). All pages will have a page number at the bottom of the page for easy reference. The program will also print a table of contents with these page numbers and fonts. Print format example below.

There will be 7 fonts printed per page, with a page number at the bottom of the page. All fonts will be printed in normal style and 14 point size.

*Print ----- Example of All fonts ----- L1 as Title*

Same as above but the font selected in list #1 will be used to print all the font names, page numbers and titles (fonts like symbol are not easily readable).

*Print ----- List #1 names only*

This list is similar to the content list in the ALL print. You will also get a font count at the top of the list. These are screen fonts only, and cannot be changed.

*Print ----- List #2 names only*

This list is the same as List #1 names only print. These can be screen fonts, printer fonts or saved font list, depending on your selection. This is useful in comparing the screen fonts to printer or saved font lists.

*Print ----- Win.Ini sub list*

This list is taken from your win.ini file. These are the fonts that Windows will use as substitutes. If the file shows "Helv=MS Sans Serif" and your document was created using Helv font, when you bring up that document, Windows will substitute MS Sans Serif for Helv.

*Delete List ----- View List*

*Add #1*

*Add #2*

Once a font is selected in either the first or second list Select delete list from the option menu, then select either add #1 or add #2. This will add the font to a list for later printing. This list will show the name of the font plus the drive/directory/name.ext of the font as it exists on your computer. To remove the selected font use the appropriate method (ie.: postscript fonts can be removed or added using ATM, Truetype can be removed or added using the Windows control panel). Once you have removed them from windows you can now use the printed list to remove (delete) the font from your hard disk. For ATM fonts you will have two files to remove. When viewing the list you can either print it out or clear it for further use.

*Characters ----- Show All Characters*

*Show Ext. Characters*

The box under the size and style box is the character list. The default is Ext. Char.. You can scroll through this list and see the extended characters that are available for the selected font. If you select All from the list, both boxes will display all the available characters in that font. When you select one of the characters you will see it enlarged next to the list. Double-Clicking on the enlarged character will copy it to the clipboard for pasting into another program.

### *Enlarge Box*

The box under the font count box. Hold the mouse button to view the selected character in 72 point size. The character selected in the All Characters or Extended Character list from list #1 will be used as the display character.

### *Register*

This is where you print out the registration form for FontMe! (at least we hope you enjoy the program enough to register it). This will keep us interested in updating the program in the future.

### *Quick Help*

These screens are here to help you get the program running without reading this document and are not meant to replace this file.

## **Section 3 ----- About Shareware**

Shareware is a try-before-you-buy process in which you are allowed to use the program for a specific amount of time. This time will vary from software to software. The grace period for this program is one week. If after that time, you find this program useful, you are expected to register with the author (see registration Information below). If however, after the specified time you do not find the program useful, you are required to remove it from use. Remember that the shareware system will only work if you support, it by registering your program with the author. This also encourages the authors of shareware to continue to write quality programs, upgrade existing programs and supply support.
