This program provides a simple method to specify and understand mortgage payment schedules.

House Mouse For Windows calculates conventional, fixed rate monthly mortgages. Graphs and table represent only principal and interest payments -- property taxes and insurance premiums are not included.

This program features:

- *easy-to-use input screen
- *mouse operated number scroll bars
- *immediate recalculation of monthly payments, total interest and total cost
- *payment, term or amount goal factors
- *printable tabular and bar chart displays
- *payment information across months, years and loan life
- *output to spreadsheet readable file

DIRECTIONS

First -- Use mouse point-and-click to select the desired **mortgage type**, which selects the amount bar range.

Second -- Click on desired Goal Factor button.

Third -- **Enter amount, rate, term and/or payment** using the mouse to drag the respective scroll bars' thumb box, by clicking on the bar arrow end, or, by clicking on the bar itself. Some possible input values are out of range when solving for amount, rate or term. Out of range values have red values. Adjust inputs to avoid the incorrect answers generated by out of range values.

Fourth -- Again using scroll bars, **enter the loan start date** (month and year).

Fifth -- Click on the darkened (activated) **Amortize** menu command, which appears once loan is fully defined, to view amortization graphs and values. Use mouse to operate graphs/values scroll bar.

Note: Testing HOUSE MOUSE FOR WINDOWS with various loan definitions indicates occasional cents variances over the life of the loan compared with other amortization programs.

Sixth -- **Click on File** and **Print** menu commands, respectively, to create a spreadsheet readable file and to print graphs/table. You may overwrite the suggested directory and filename found in the subsequent prompt box.

Next -- Click on the **Reset** menu command to clear loan definition, graphs and report. Amortization At A Glance screen may be closed by selecting the **Exit** command from the File menu option on this screen.

Lastly -- End application by clicking on **Exit** command from the File menu option of the input screen.

Valid Input Ranges

Rate $\leq 11\%$, Term ≤ 30 years, Payment $\leq \$6,000$

Spreadsheet Readable File

The File command makes a comma delimited text file. Lotus 1-2-3 users may import this file with the spreadsheet command "/ File Import Numbers."

Mortgage Type Amount Ranges

"Conventional" < \$202,300 < "Jumbo"< \$600,000)

Goal Factor

The goal factor is the item being calculated, thus it has no input scroll bar. The goal factor has a yellow answer box. (Default = payment button.)
