

ALLONGE TO NOTE

Annexed to that certain Mortgage Note made by MARIO CANELA & MONICA CANELA, natural persons jointly, in favor of HOUSATONIC HABITAT FOR HUMANITY, INC., a Connecticut Corporation, having an office at 51 Sugar Hollow Road, Danbury, CT. 06810 ("Housatonic") in the original principal amount of one hundred four thousand seven hundred seventy-eight and 56/100 Dollars (\$104,778.56), made by MARIO CANELA & MONICA CANELA (the "Borrower") dated February 9, 2006 (the "Note"), concerning that real property commonly known as 16B Patch Street, Danbury (the "Premises").

Housatonic hereby endorses and assigns all of its right, title and interest in, to and under the Note to FAIRFIELD COUNTY BANK, a Connecticut Corporation, with an office at 150 Danbury Road, Ridgefield, CT 06877 ("FCB").

This assignment is pursuant to a certain Pledge Agreement from Housatonic in favor of FCB dated October 2, 2008 securing a certain line of credit loan facility (the "Credit Facility") evidenced by a note in the original principal amount of \$500,000 dated October 2, 2008 made by Housatonic in favor of FCB. FCB reserves the right to assign the Note and the Mortgage securing said Note further, in accordance with its loan documents, including to Housatonic. Upon termination of the Credit Facility and payment in full of any outstanding balance due thereunder, FCB, its successors or assigns will promptly re-assign the Note to Housatonic.

Housatonic agrees to hold FCB, its successors and/ or assigns harmless and otherwise indemnify it from any claim brought by the Borrower under the Note, the mortgage securing the Note or from the loan transaction between Housatonic and the Borrower.

Housatonic represents that as of the date hereof, there is no default under the Note or the mortgage securing the Note and that there is no threatened or pending litigation involving Housatonic, the Borrower, the Note or the Premises.

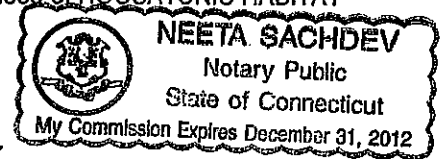
