Having Trouble?

If you are getting an **Invalid Property Value** message this is usually due to the fact that this program tried but could not install the font resource (needed for this program) into the Windows 95 font table. Why? Good question. Some programs (especially font managers) take over control of the font table and don't allow installation of fonts unless they are installed manually or through the font manager. Is this a nice thing to do? We don't think so and we don't believe Microsoft does either. There is a fix though. To run our program correctly you will have to manually install the font(s) by using the **Install New Font** option in the **File Menu** of the Windows 95 **Font Folder**. All of our true type fonts (usually just one) are located in our program's directory. **Make sure** that you **remove** the **check mark** from the **Copy fonts to Windows folder (check box)** before you click the **OK** button. If your still having trouble call Technical Support.

When you click this button a context-sensitive help video will play giving you a detailed explanation on how to solve the current types of problems. For even more help, click on the question mark button for context-sensitive written help text.

When you click this button the LF Software introduction video plays.

This is the blackboard where the fractions and operators will appear.

Enter your answers in these two text boxes. There is a box for both the numerator and denominator unless the answer reduces down to an integer. Press the ENTER key or click over a box to give it the focus. You can click the plus/minus button to change the sign of your answer from positive to negative or from negative to positive.

Click on this button or press F5 to generate and display a new problem.

Click this button or press F3 to see if your answer is right or wrong.

Click on this button or press F2 to change the sign (+/-) of your answer. This button is a toggle and will either display a negative sign or no sign (which is the same thing as positive).

This is Leon, the Fraction Wizard.

This menu bar item is the Options menu which allows you to turn the sound on or off.

You may select one of three levels. Level one is the elementary level where you are introduced to fractions with relatively small numerators and denominators. Level two is the intermediate level where you will work with signed fractions and larger numerators and denominators than in the elementary level. Level three is the advanced level where you will work with signed fractions and mixed numbers.



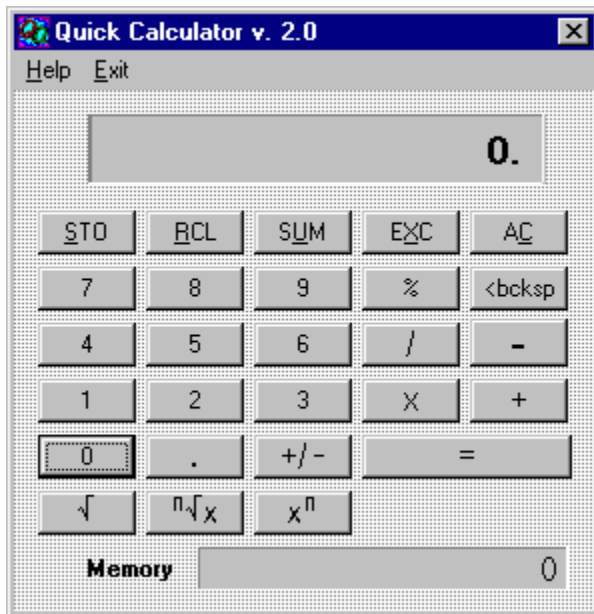
Clicking on this option will display the number of correct and incorrect answers that you have chosen. If you answered a problem correctly a new problem is automatically generated. You may reset your score (start over).

Playing Sounds

To play the sounds that come with this program, you'll need to click over the **Sound** option located in the options menu or click over the sound button. The current option selected will have a check mark in front of or the button will be recessed. The settings are automatically saved when they are changed. To properly hear the sound (.WAV) files you'll need to have a sound driver installed as well as a sound card that gives you sound capabilities. Consult your Windows or sound card documentation for further assistance.

Calculator Help



Click the part of the Calculator window that you want to know more about.

Clicking on this key causes the displayed value to be stored in the memory register replacing any value already in that register.

Clicking on this key copies the contents of the memory register to the displayed value window. The value in the memory register now becomes the displayed value.

Clicking on this key sums the displayed value and the contents of the memory register with the result being stored in the memory register.

Clicking on this key causes the displayed value and the contents of the memory register to be exchanged.

Clicking on this key clears the current calculation and displayed value. This key **does not** clear the memory register. To do that click on this key and then click the STO key.

percent function.

Clicking on this key deletes the last digit of the displayed value during the entry process. This key is general used to edit an entry if the wrong digit was pressed.

division operator.

multiplication operator

subtraction operator

addition operator

= performs any calculation on the previous two numbers.

square root function

Clicking on the key finds the **n th** root of **x** . Enter **x** , click this key, enter **n** and click the EQUAL key.

Clicking on this key calculates x to the **n th** power.

the memory register

changes the sign of the displayed value

inserts a decimal point

Glossary

Term	Definition
Addition	The sum of two numbers a and b, where a and b are the addends.
Additive Inverse	The additive inverse of a number, b, is the opposite, -b.
Algebra	Algebra is a continuation and extension of the rules of arithmetic into a more general level.
Associative Property of Addition	$a + (b+c) = (a+b) + c$
Associative Property of Multiplication	$a \times (b \times c) = (a \times b) \times c$
Commutative Property of Addition	$a + b = b + a$
Commutative Property of Multiplication	$a \times b = b \times a$
Complex Fraction	This is any fraction with either the numerator, the denominator, or both containing a fraction.
Constant	A constant is a fixed number.
Denominator	For the fraction, a/b, b is the denominator.
Distributive Property	$a(b + c) = ab + ac$
Division	Division can be thought of as repeated subtraction. In the expression $a \div b = c$, a is the dividend, b is the divisor, and c is the quotient. The number a is divisible by b if the remainder is zero.
English System of Measurement	This is the system of measurement used in the United States.
Equation	This is a mathematical sentence stating that two expressions are equal.

Equivalent Equations	These are equations that have the same solutions.
Equivalent Fractions	These are fractions that have the same numerical value.
Formula	A formula is a sentence expressed symbolically showing the mathematical relationships among variables.
Fraction	A fraction is any number that can be written in the form a/b with $b \neq$ zero.
Identity Element of Addition	The additive identity is the number zero.
Identity Under Multiplication	The multiplicative identity is the number one.
Improper Fraction	An improper fraction is a fraction with the top number greater than or equal to the bottom number.
Integers	$\{\dots-3,-2,-1,0,1,2,3\dots\}$
Inverse	The multiplicative inverse of a number, b , is $1/b$.
Least Common Denominator	The LCD of a set of numbers is the smallest number that each of the numbers in the original set will divide into evenly.
Mixed Numbers	A mixed number is the sum of a whole number and a fraction.
Multiple	A multiple of the number, b , is a whole number times b .
Multiplication	In the expression, $a \times b = c$, a is the multiplier, b is the multiplicand, and c is the product.
Multiplication Principle of Equality	This states that you can multiply both sides of an existing equation by the same non-zero number.
Negative Numbers	The negative numbers are the numbers less than zero.
Numerator	The numerator is the top number in a given fraction.
Opposite	The additive opposite of b is $-b$. The additive opposite of $-b$ is b .

Pi	Pi is the number of times the diameter divides into the circumference of a circle. It is approximately 3.14 times. ($\pi \approx 3.14$)
Place Value	The place value of a digit in a decimal number is the name of the place or location of that digit in the decimal number.
Positive numbers	The positive numbers are those numbers greater than zero.
Prime Factorization	The prime factorization of a number is the expression of that number as a product of its prime factors.
Prime Numbers	{1,2,3,5,7,11,13,17,19,23,...}
Proper Fraction	A proper fraction is one with the top number smaller than the bottom number.
Proportion	A proportion is an equation with one fraction set equal to another fraction.
Rate	A rate is a ratio of two numbers with different units like 40 miles/ 2 hours.
Ratio	A ratio is a fraction, a/b .
Reciprocal	The reciprocal of a fraction, a/b , is the fraction, b/a .
Repeating Decimal	A repeating decimal expansion of a fraction is one in which a repeating pattern of digits occurs.
Solution	A solution of an equation in one variable is a number that makes a true sentence of the equation. It is also a root of the equation.
Subtraction	In the subtraction expression, $a - b = c$, a is the minuend, b is the subtrahend, and c is the difference.
Terminating Decimal	A terminating decimal expansion of a fraction is one in which the decimal expansion has all zeros from some point on.
Undefined Division	Division by zero is undefined.
