We need it to run the contest, not to sell to the marketers. For the purposes of the contest, we will encourage you to use an assumed name, or "handle." At the minimum we need an image and a biography/description for your entrant. We will, at our sole opinion, accept anything else digital, or digitizable, to supplement a contestant's virtual presence.

We would prefer sound files to be 8 bit, 11 kHz  
We would prefer pictures to be 256 color GIFs, or 24bit JPEGs  
We would accept movies in any standard format  
We will accept text in any standard format
