This version of Adobe Photoshop is intended to give you a preview of the features of Adobe Photoshop 5.5, which now includes Adobe ImageReady 2.0.

It includes nearly all of the core features found in the full version, except that it will not allow you to save, print, export, copy files to other applications via the clipboard or use drag and drop to copy images to other files. Furthermore, to minimize its size, this tryout version includes only a small sampling of the plug-in filter effects available with the full version. The full version of Adobe Photoshop 5.5 includes a total of more than 95 different effects filters. This tryout version of Photoshop also installs a minimum set of ICC Profiles.

- 64 MB RAM to run Adobe Photoshop or ImageReady separately (96 MB to run the two applications concurrently)

1. Double-click the Setup.exe file in the Photoshop 5.5 Tryout folder.
2. Follow the on-screen instructions.
