

## Encoding for Personal Contact Information (PCI)

### SUMMARY

Extensive use of Internet electronic mail demonstrates a need to be able to communicate various descriptive information about participants. The information ranges from telephone and postal addressing, to an indication of the media supported by their electronic mail and information processing environment. This specification provides a basis for encoding such "PCI" business card information by using the STIF [CROC93] syntax.

A MIME Content sub-type is defined for carriage of PCI information.

## 1. INTRODUCTION

Extensive use of Internet electronic mail demonstrates a need to be able to communicate various descriptive information about participants. The information ranges from telephone and postal addressing, to an indication of the media supported by their electronic mail and information processing environment. This specification provides a basis for encoding such "PCI" business card information by using the STIF [CROC93] syntax.

EMail often contains a set of information headers, or free-format text, at the end of the message intended to convey various information about the originator of the message. There is no formal specification which permits automated exchange of such information so that it can be incorporated into an on-line information base. Further, there is no way for a sender to provide recipients with similar information about each other.

At its simplest, the PCI/STIF/MIME mechanism permits the exchange of "business card" information in an automated fashion. Hence, its benefits should be an on-line equivalent to that derived when business associates exchange contact information.

This specification provides a detailed structure for encoding the wide range of contact and description information needed by communicants. It includes fine-grained specification for delivery through various media and specification of the human communication media support available to a participant.

A MIME Content-type is defined for carriage of PCI information.

## 2. MIME Content-Type for Carriage of PCI Information

PCI information is encoded with the STIF syntax, and can be carried in MIME [BORE92] messages:

MIME type name:               TEXT  
MIME subtype name:            PCI  
Required parameters:         none  
Optional parameters:         charset = xxx

This defines the alternate STIF character set. Legal character sets are the same as defined in MIME.

Encoding considerations:

Alternate character set characters, and some US-ASCII characters cannot be sent through some transport services directly. Transports that do not support such data should encode the data appropriately. Where possible, it is recommended that quoted-printable be used, to preserve some level of human-readability.

Security considerations:

See separate section in the document.

Published specification:

This document and its companion, Structured Text Interchange Format (STIF), with additional specification at the end of this section.

Rationale:

Provides human- and machine-processable means of encoding common personal contact information. This will permit automated processing, such as for maintaining personal files of contact information.

Contact-info:

See Contact section, below.

Detail specific to MIME-based usage:

Within a MIME body-part, PCI data are to be encoded as a series of headers, in the style of RFC 822. Each header has a name, which serves as the reference key to a set of data. Usually, the key should be a version of the person's name which has been stripped of secondary text, such as titles and salutations:

### 3. PCI FRAMEWORK

PCI permits structured, extensible specification of information about a person or some other “reachable” resource. Use of the STIF syntax permits machine processing of the PCI content. PCI entries are specified one per STIF Header, rather than in the compressed, list-oriented format of RFC822 which allows multiple addresses per line.

Information is specified by a set of STIF fields which are named from a single, flat name space. Extensions to this document are to be registered with IANA, as described in the MIME specification [BORE92]. For convenience, this document discusses the initial set of PCI fields in three different sections. The first provides information about various addressing alternatives, including electronic mail, postal mail, facsimile transmission, and telex transmission. The second set of PCI fields cover descriptive information about a person, such as their personal name, organizational affiliation, title, and telephone contact number. The third set of information specifies the capabilities of the person’s electronic mail service. This allows the sender or agent software for the recipient to determine what alternate routing or gateway translations are to be provided.

#### 3.1 Basic Syntax

Note that RFC 822 lists of addresses, within a field, have been modified to be lists of STIF headers. PCI entries may contain two types of information:

1. Addressing Detail provides basic contact information, sufficient to allow contact via a variety of transport mechanisms, such as postal, telex and email.

2. Description Detail provides information about the addressee, some of which may be required by some media, but which may otherwise be of interest. The addressee's name and the name of their organization are examples of such information.

3. Capabilities Detail provides guidance about the addressee's support of various on-line media and, possibly, conversions they would prefer when they lack a capability. For example, they may have a fax machine but not have on-line graphics capabilities and they may wish that graphics body-parts be sent to them via facsimile. (This specification does not dictate behavior by electronic mail transport services, so that use of capabilities information is outside of the scope of this document.)

## 4. ADDRESSING DETAIL

### 4.1. Electronic Mail Detail

Specification of electronic mail addresses is similar to the style used for RFC 822-based encoding, except that reference to the formal, presentation name of a person is separated into its own field, since it may be used without any reference to email. Further, an email address may be characterized as to type. This is intended to allow user agents to perform contingent actions, depending upon the type of email address. For example, a reply to a message which includes an email reference to a list or bboard may cause the user agent to obtain confirmation from the sender, so that such addresses are not included in replies automatically and possibly by accident.

### 4.2. Postal Mail Detail

The specified fields refer to typical categories of postal information that are used. Note that such information is order-dependent to the Postal Service. For example, in the United States, an address which contains both a street address and a post office box address is delivered to whichever address is "lower" on the envelope.

Courier-delivered mail specification is treated as a type of postal delivery, although it may require additional information, such as the specific courier agency to be used. Also, some courier agencies require the specification of the recipient's telephone number.

Since the service provided by one electronic mail gateway may differ from that of another, or the authorization to use it may be restricted, specification of a particular postal gateway is permitted.

### 4.3. Facsimile Mail Detail

Facsimile addresses are easily specified, since they consist only of a telephone number. However, transmission of facsimile may require essential configuration information, such as the degree of precision to the image to be sent or variations in the cover page to be used. As with postal, the specification may indicate a particular gateway service that is to be used.

## 5. DESCRIPTION DETAIL

A small set of initial descriptors for an addressee are defined here. The set is by no means intended to be definitive. Rather, it is intended to be indicative of the range of such information that may be useful and appropriate to specify.

## 6. CAPABILITIES DETAIL

A sender may choose a delivery address or medium based upon knowing the capabilities of the recipient. Similarly, an electronic mail gateway may choose particular behaviors, such as encoding formats, based upon such knowledge. Such information may be accessible through dynamic query of a directory service. However, this may not be possible. An alternative is to allow the addressee's descriptive information to contain specification of the range of media support available to that addressee. For simplicity, this specification simply provides for listing the range of MIME content types and sub-types that the addressee's system can support.

Since stif supports aggregation of references within nested subsets, <a-capable> specifications may be used for **each** of the nested sets of addressing information. A user's different mailboxes may have different capabilities.

## 8. SECURITY CONSIDERATIONS

This specification covers data encoded within a portion of an email message. It contains addressing and source-identification information which is not specially authenticated. No special provision is made for confidentiality of the data. No other security-related concerns apply.

## 9. ACKNOWLEDGEMENTS

STIF developed out of a series of conversations, but was initially focused exclusively for use as enhanced electronic mail headers. ## A. Example of Personal Contact Information

It is common for Internet mail to contain extensive information about its sender. For example:

When encoded as a PCI header, this becomes:

Note that the entire entry is tagged with a canonical form of the person's name. This tag is different from the formal presentation string for that person's name. That is, name is different from the header-name for the header containing the name field. Leading and trailing information, such as "Dr." or "Ph.D." and "Jr." should be removed from the header-name, to facilitate use of this string as a database storage and search key.
