4. MPEG ON MACINTOSH

The NET TOOB Stream Mac Plug-In supports playback of standard MPEG and low bit-rate/variable frame-rate MPEG for Power Macintosh.

Macintosh users can now use the NET TOOB Stream Mac Plug-In to playback MPEG digital video extensions including .MPG, .M15 and .M75 on Mac OS 7.5.3 (or higher) systems as downloaded files or real-time on-demand streams.

The NET TOOB Stream Mac Plug-In is compatible with a wide range of Web and Intranet based MPEG, including Low Bit-Rate/Variable Frame-Rate (LBR/VFR) MPEG thus broadening the ability for content providers to deliver high quality streamed or quickly downloaded MPEG for Macintosh audiences. Content providers can now post the same interleaved and synchronized audio & video file viewable on Mac and PC platforms.

System Requirements:

- Mac OS 7.5.3 or higher (Threads Manager required).
- Netscape Navigator (version 2.0 or higher).
- Microsoft Internet Explorer (version 4.0).
- PowerPC processor.
- 28.8 Kbps modem or faster.

5. COMMAND LINE OPTIONS

There are several command line options for the NET TOOB Stream player.(DXPLAYER.EXE)
The command line options are:

- /FULL Full Screen
- /MUTE Sound Off
- /SOUND Sound On
- /LOOP Play In A Loop
- /ONCE Play Once Only
- /EIGHTH Smallest Video Size(1x)
- /QUARTER Medium Video Size(2x)

These should be placed after the media clip file name. For example:

```
DXPLAYER C:\TEST_VID\VIDEO.M15 /FULL /MUTE /ONCE
```

will play the VIDEO.M15 clip in full screen mode, with no sound, one time. These commands override the default and user settings. The above, for example, will work even if the default size is small(1x) or medium(2x) and looping is set to ON. This would be useful if, for example, you wanted video files(MPEG, AVI, MOV, etc...) to play in a loop and audio files(WAV, MPA, MP2) to play just once. You would just change the setting in your Windows or Netscape Registry(or INI file in Win 3.1) For a short cut, you can just use the first letter of each word(IE: /F /M /S /L /O /E and /Q).
